## Cyflwyniad

Yn 2001 daeth Comisiynydd Plant Cymru yn bencampwr plant cyntaf y Deyrnas Unedig. Dewiswyd y Comisiynydd gyda chymorth plant a phobl ifanc; ac mae'n sicrhau bod plant a phobl ifanc yn dysgu am eu hawliau ac yn cael eu cadw'n ddiogel. Keith Towler yw'r Comisiynydd cyfredol, hyd at fis Mawrth 2015, pryd y bydd ei gyfnod o saith mlynedd yn y swydd yn dod i ben.

Yr amcangyfrif hwn yw'r un terfynol a gyflwynwyd gan Keith Towler. Gellir newid y ffigurau dangosol yn dilyn trafodaethau rhwng y Comisiynydd newydd a Gweinidogion Cymru.

Cyflwynir yr amcangyfrif cyllideb hwn i Weinidogion Cymru fel sy'n ofynnol o dan baragraff 6(2) o Atodlen 2 o Ddeddf Safonau Gofal 2000. Mae'n pennu'r adnoddau sy'n ofynnol i alluogi'r Comisiynydd i gyflawni ei swyddogaethau statudol.

## Introduction

The Children's Commissioner for Wales became the UK's first children's champion in 2001. The Commissioner was selected with help from children and young people; and makes sure that children and young people learn about their rights and are kept safe. Keith Towler is the current Commissioner and until March 2015, when his seven year term of office ends.

This estimate is the final one submitted by Keith Towler. The indicative figures will be subject to change following discussions between the new Commissioner and Welsh Ministers.

This budget estimate is submitted to Welsh Ministers as required by paragraph 6(2) of Schedule 2 of the Care Standards Act 2000. It sets out the resources required to enable the Commissioner to discharge his statutory functions.

## Summary

The budget requirement for 2014-15 is £1,715,000, which remains the same as that provided in 2013-14.
