Dear Minister

You will have seen the letter that I have now received from Jane Holownia of the Wales Audit Office dated 31st May 2019. I note and understand the concerns that she raises, many of which are common to a number of other local authorities across Wales, but which are particularly marked here given the size of the Authority and our current political composition. In light of the concerns raised, I am writing to request that you consider providing us with support pursuant to section 28 of the Local Government (Wales) Measure 2009 to help us address these challenges.

Having considered our current position in detail, it seems to me that there are two main areas where we would particularly welcome your support.

Firstly, like many other authorities, we face enormous pressures around delivering social services provision to our most vulnerable citizens. As a small authority, our service requirements are particularly volatile and small variants in service user numbers can have a significant impact on our budget. I would therefore welcome support in the following specific areas:

- Expertise to ensure that we are making the best use of financial resources within Social Services.
- Review of processes to ensure we are maximising all available resources
- Review of impact of complex, high cost and challenging cases on such a small authority.

Secondly, we are experiencing difficulty in delivering change which requires difficult and challenging decisions because of our political balance. Whilst all members appreciate their duties under the Code of Conduct, and the need to act in the best interests of our citizens, we are also conscious that political differences can lead to deep division and conflicting views on how best to manage our situation and eventually that can hinder progress.

Accordingly, I would welcome help in the following areas:

- Support with member interaction given the current fractious position and financial challenge.
- The involvement of an experienced figure who could act as an honest broker between Lead administration, opposition and CMT.

In making these requests I am aware that during a previous intervention around education provision, support was offered in the form of a recovery board and whilst being helpful in identifying and targeting improvement, this was a significant drain on staff time and resources and the requirement to provide administrative support and make managers available to report to and attend that board. I would be very grateful if, in this instance, assistance could be provided by the provision of expert support to the corporate management team and political leaders to deliver the change needed.

I firmly believe that Merthyr Tydfil County Borough Council is able to meet the challenges ahead and serve the people of Merthyr Tydfil effectively and efficiently and I would very much welcome your support to enable us to achieve this.
