Paper for Council for Economic Renewal

Prioritising the National Transport Plan

1. Purpose

1.1. This paper provides the Council for Economic Renewal with an update on the prioritisation of the National Transport Plan.

2. Action Required

2.1. The Council for Economic Renewal is asked to note the contents of this paper and provide feedback during the discussion on 1 December.

3. Background

- 3.1. Since the last paper presented to you in July officials have being working to prioritise the interventions in the National Transport Plan (NTP). Prioritising the NTP will enable interventions to be rescheduled to focus on delivery of Welsh Government's priorities for transport. The prioritised programme will be aligned with the wider objectives for the wider portfolio, and consistent with delivery of the Welsh Government agenda. Prioritising the NTP also provides the opportunity to reschedule the delivery of interventions in light of capital and revenue budget pressures.
- 3.2. The prioritisation exercise examined only those interventions listed in the NTP. The interventions were initially reviewed in light of the following statements as agreed with the Minister for Local Government and Communities:
 - Address the mobility issues faced by people living in poverty in deprived communities, by improving access to employment, services and facilities.
 - Ensure the transport network in Wales operates more efficiently and effectively.
 - Tackle urban congestion to unlock sustainable growth.
 - Improve access to key sites and settlements, particularly in rural areas, with emphasis on improving the quality and provision of healthy and more sustainable travel choices.
 - Improve the capacity and reliability of the main east-west strategic Trans European corridors in Wales.
- 3.3. Interventions that fell into one of the following categories were excluded from the prioritisation process:
 - Interventions that have been completed, or are soon to be completed.
 - Interventions that are policy or planning principles, and therefore guide day-to-day work.
 - Ongoing interventions that directly deliver a Government commitment.

The remaining interventions were segmented by mode and assessed in terms of their relevance to the five statements.
