This discussion paper has been written by officials of the Welsh Government. Ministers have not had an opportunity to comment on the contents. Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

Free school meals data

Summary

- 1. This paper looks at the impact on the 2018-19 Settlement of updating the Free School Meal (FSM) data for nursery, primary and secondary school pupils if a two/three year average of FSM data are used instead of single year.
- 2. Table 1 details the percentage shares of the latest (2017) Free School Meal PLASC data for nursery, primary and secondary school pupils and the difference in these percentage shares using a two/three year average of the FSM data.
- 3. Table 2 details the published SSA for the School Services Sector and notional SSA amounts using two and three year averages of FSM data.

Views sought

4. Members are asked to provide their recommendation on the treatment of FSM data in the formula for future settlements.

Background

- 6. A previous DSG paper (paper 08 2017 PLASC data update) highlighted that in the latest PLASC (2017) data, overall eligibility for FSM decreased, in particular in Blaenau Gwent, Caerphilly and Flintshire. It also highlighted that these decreases caused significant percentage changes in Total SSA, in particular for Blaenau Gwent and Caerphilly.
- 7. At the 2017 September DSG meeting the group raised concerns about the volatility of the FSM data and the impact this has for some local authorities in the 2018-19 Settlement. This paper is to look closer at the FSM data and consider options to potentially reduce some of the volatility.
- 8. The current eligibility criteria for FSMs in Wales are parents of pupils who are still at school and receive one of the following:
 - Income Support
 - income-based Jobseeker's Allowance
 - income-related Employment and Support Allowance
 - support under Part VI of the Immigration and Asylum Act 1999
 - the guaranteed element of Pension Credit
 - Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
 - Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
 - Universal Credit (temporary measure)

This includes nursery children who attend full days and also sixth form students. Young people attending Further Education Institutions are not eligible for FSM. Children who get paid these benefits directly, instead of through a parent or guardian, can also get free school meals.

Analysis

9. Table 1 details the percentage shares of the 2017 FSM data, a calculated two year average using 2016 and 2017 data and a three year average using the 2015, 2016 and 2017 data. These are broken down into nursery and primary schools, secondary schools and all pupils. It also details the difference in percentage points of the calculated two and three average from the 2017 PLASC FSM data.

Nursery and primary schools

- 10. The effect on the nursery and primary schools IBA using a two year average of the FSM data shows Wrexham had the largest percentage share decrease, down 0.2 percentage points when compared with the single year. Blaenau Gwent and Flintshire had the largest increases, up 0.3 and 0.2 percentage points respectively.
- 11. The effect on the nursery and primary schools IBA using a three year average of the FSM data shows Wrexham again had the largest percentage share decrease, down 0.3 percentage points when compared with the single year. Blaenau Gwent, Caerphilly and Flintshire had the largest increases, up 0.4, 0.2 and 0.2 percentage points respectively.

Secondary schools

- 12. The effect on the secondary schools IBA using a two year average of the FSM data shows Cardiff had the largest percentage share decrease, down 0.3 percentage points when compared with the single year. Caerphilly, Blaenau Gwent and Carmarthenshire had the largest increase, up 0.3, 0.2 and 0.2 percentage points respectively.
- 13. The effect on the secondary schools IBA using a three year average of the FSM data shows Cardiff again had the largest percentage share decrease, down 0.4 percentage points when compared with the single year. Swansea was also down 0.3 percentage points. Blaenau Gwent and Caerphilly had the largest increases, both up 0.3 percentage points.

All pupils

- 14. The effect on all pupils using a two year average of the FSM data shows Cardiff, Swansea and Pembrokeshire had the largest percentage share decreases, down 0.2 percentage points when compared with the single year. Blaenau Gwent and Caerphilly had the largest increase, up 0.2 percentage points.
- 15. The effect on all pupils using a three year average of the FSM data shows Cardiff again had the largest percentage share decrease, down 0.3 percentage points when compared with the single year. Blaenau Gwent and Caerphilly again had the largest increases, up 0.4 and 0.3 percentage points respectively.
- 16. Table 2 details the latest published school services sector SSA along with notional SSA amounts for the school services sector based on the 2018-19 settlement utilising the calculated two and three average FSM data.

Percentage difference incorporating a two year average of the FSM data

17. The results show the largest percentage difference increase was for Blaenau Gwent of 0.9 percent. Caerphilly and Flintshire also had notable percentage difference of 0.3 percent and 0.2 percent respectively when compared to the 2018-19 published settlement. The results show the largest percentage decrease for Pembrokeshire (down at 0.3 per cent), followed by Wrexham and Swansea (both down at 0.2 per cent).

Percentage difference incorporating a three year average of the PLASC FSM data

18. The results show very similar results, notably a 1.3 per cent increase for Blaenau Gwent. The largest percentage decrease was for Pembrokeshire (down at 0.4 per cent), followed by Wrexham and Swansea (down at 0.3 per cent, respectively).

Conclusion

19. The FSM data has been considered by the group to be relatively volatile. In particular the data used in the 2018-19 settlement showed a significant reduction in FSM eligibility for Blaenau Gwent. Until validated 2018 PLASC data becomes available, it is not possible to determine whether this pattern will continue.

Distribution Sub-Group (2018) Paper 04 – Updating the free school meal data

- 20. The group had previously discussed whether the volatility in the 2017 FSM data was attributable to the roll out of Universal Credit. However, it was concluded the effect on the 2018-19 Settlement was negligible.
- 21. For the 2019-20 settlement a total of six local authorities will be affected by the roll out of universal credit and thus the impact of FSM eligibility and the 2019-20 settlement will be more significant.
- 22. The group is asked to consider whether a two or three year average of FSM data is applied when calculating future settlements. This could be one of the examples provided in this paper, until alternative data is available, or until the data becomes less volatile.
