Mae'r Panel yn cydnabod y gall rolau penodol ar gyfer aelodau yn enwedig o fewn y cynghorau tref a chymuned mwy, er enghraifft cadeirydd pwyllgor, olygu mwy o gyfrifoldeb. Mae hefyd yn debygol y bydd gan y cynghorau mwy nifer fwy o bwyllgorau, sy'n adlewyrchu eu lefel gweithgarwch. Mae'r Panel felly wedi penderfynu bod yn rhaid i gynghorau yng Ngrŵp A neilltuo taliad o £500 yr un am isafswm o un uwch-rôl ac uchafswm o bum uwch rôl. Gall cynghorau Grwpiau B, C a D dalu hyd at bum taliad cyfrifoldeb (hyd at £500) am rolau penodedig.

<b>42</b> - Gall cynghorau tref a chymuned yng Ngrwpiau B neu C wneud taliad blynyddol o hyd at £500 yr un i hyd at 5 aelod i gydnabod cyfrifoldebau penodol. **Addendum to Paragraph 13.16, Table 10 (Determination 42) and Summary of new and updated determinations contained in this report (Determination 42).**

**Paragraph 13.16 now reads:**

The Panel recognises that specific member roles especially within the larger community and town councils, for example a committee chair, will involve greater responsibility. It is also likely that larger councils will have a greater number of committees, reflecting its level of activity. The Panel has therefore determined that councils in Group A must make available a payment for a minimum of one senior role and a maximum of five senior roles of £500 each. Councils in Groups B and C can pay up to five responsibility payments (of up to £500) for specified roles.

**Table 10 (Determination 42) now reads:**

<b>42</b> – Community and town councils in Groups B or C can make an annual payment of up to £500 each to up to 5 members in recognition of specific responsibilities. This is in addition to the £150 payment for costs and expenses.	Yes – it is optional to pay it for up to 5 members and, if it is paid, the amount (up to £500) must be decided.
