Natural Resources Conference: Summary Report

Making the best of Wales' natural resources in the 21st Century

Introduction

The Minister for Natural Resources & Food hosted a conference at the Swalec Stadium, Cardiff, "Making the best of Wales' natural resources in the 21st Century". The conference focused in the main on the delivery of the Welsh Government's natural resource management objectives, including the Environment Bill White Paper proposals, within the context of wider policy delivery across the Department for Natural Resources & Food.

Around 160 stakeholders attended the conference from a variety of sectors including agriculture, environment, energy, business, water industry, land management and recreation.

A full transcript of all the comments and views of stakeholders captured through the *MeetingSphere* technology is available. The report below contains a précis of key themes, comments and questions captured through the day.

- The links between the Environment, Future Generations and Planning Bills.
- The area-based approach and Natural Resource Management Plans.
- The consultation on the Environment Bill White Paper and the engagement process around it.
- The ecosystem approach and ecosystem services.

- Issues around the economy and funding.
- The role of Natural Resources Wales.
- The need for education early on.
- Issues around sustainability.
- The importance of building on existing mechanisms.
- Specific issues around climate change, forestry, water, marine, biodiversity and landscapes.

There were a number of comments and questions on both presentations, which are set out in the transcript of comments.

Environment Bill White Paper– key themes and questions

Dr Andy Fraser, Natural Resource Programme in the Welsh Government, introduced the White Paper.

There was then an opportunity for roundtable discussions on the White Paper, focusing on the proposals relating to the area-based approach for natural resource management.

Areas of general consensus in relation to the proposals for an Environment Bill included:

- Support for general direction of overall package of proposals in relation to an areabased approach to integrated natural resource management.
- Recognition of the need to capture differing views and understanding of an 'area-based approach' and the need for practical illustration.
- Recognition of the critical links to the wider legislative programme, and in particular to the Future Generations Bill and Planning (Wales) Bill.
- Recognition of the importance of involving a wide range of stakeholders and policy areas, and using existing partnership and communications mechanisms in coordinating and gathering evidence for the area-based approach.
- Recognition of the need to engage and understand impacts of proposals on industry, businesses and land owners. For example, to engage private sector representatives in development of proposals around ecosystem services.

Comments received during the Environment Bill White Paper workshop session are included in the transcript of comments captured by MeetingSphere and will form part of the White Paper consultation.
