Bydd Gorchymyn Cau Priffyrrd (Stryd Wellington/Maes Parcio Tesco/Albert Row, Abertawe) 2018 (“y Gorchymyn”) yn peidio â chael effaith os daw’r caniatâd cynllunio mewn cysylltiad â’r datblygiad i ben neu os caiff ei ddirymu.

**TOWN AND COUNTRY PLANNING ACT 1990
AND THE HIGHWAYS ACT 1980**

**THE STOPPING UP OF HIGHWAYS
(WELLINGTON STREET/TESCO CAR
PARK/ALBERT ROW, SWANSEA) ORDER
(2018 NO. 65)**

The Welsh Ministers have made an Order under section 248 of the Town and Country Planning Act 1990 (“the 1990 Act”) and section 125 of the Highways Act, to authorise the stopping up of the length of highway described in Schedule 1 to this Notice; to provide for the new lengths of highway described in Schedule 2 to this Notice; to improve the length of highway described in Schedule 3 to this Notice; and to provide new private means of access described in Schedule 4 to this Notice; and to enable the development described in Schedule 5 to this Notice to be carried out.

The Stopping Up of Highways (Wellington Street/Tesco Car Park/Albert Row, Swansea) Order 2018 (“the Order”) will cease to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge at the office of Swansea City & County Council, Civic Centre, Oystermouth Road, Swansea, SA1 3SN during normal office hours or may be obtained free of charge from the address below quoting reference qA1347106.

If a person is aggrieved by the Order, on the ground that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 24 August 2018 make an application for the purpose to the High Court.

Darn afreolaidd ei siâp o briffordd ar ochr ddeheuol Stryd Wellington, Abertawe sydd gyferbyn â'r Maes Parcio Aml-lawr, sy'n 93 o fetrau yn y man hiraf ac yn 10 metr yn y man lletaf ac a ddangosir â dotwaith ar y plan a adneuwyd.

Darn bach afreolaidd ei siâp o briffordd ar ymyl deheuol y gornel rhwng Stryd Wellington ac Albert Row, sy'n 5 metr yn y man hiraf ac yn 1 metr yn y man lletaf ac a ddangosir â dotwaith ar y plan a adneuwyd.

SCHEDULES

SCHEDULE 1 (All measurements are approximate)

Description of the length of highway to be stopped up under this Order

An irregular shaped length of highway located at the south western end of Wellington Street, Swansea being the exit of the Tesco Car park, with a maximum length of 16 metres and a maximum width of 4 metres and shown by zebra hatching on the deposited plan.

SCHEDULE 2

Description of the lengths of new highway to be provided under this Order

An irregular shaped length of highway located on the south western end of Wellington Street, Swansea, with a maximum length of 29 metres and a maximum width of 2 metres and shown by stipple hatching on the deposited plan.

An irregular shaped length of highway located on the south side of Wellington Street, Swansea opposite the Multi-storey Car park, with a maximum length of 93 metres and a maximum width of 10 metres and shown by stipple hatching on the deposited plan.

A small irregular shaped length of highway located on the southern edge of the corner between Wellington Street and Albert Row, with a maximum length of 5 metres and a maximum width of 1 metre and shown by stipple hatching on the deposited plan.

SCHEDULE 3

Description of the length of improved highway to be provided under this Order

An irregular shaped length of highway being the full length of Wellington Street, and the northern part of Albert Row, Swansea, with a maximum length of 259 metres and a maximum width of 43 metres and shown as cross hatching on the deposited plan.

Mynedfa breifat newydd ar ochr ogleddol pen dwyreiniol Stryd Wellington, Abertawe sydd gyferbyn â'r Maes Parcio Aml-lawr, sy'n 24 o fetrau yn y man hiraf ac yn 5 metr yn y man lletaf ac a ddangosir â llinellau lletraws golau ar y plan a adneuwyd.

Y Datblygiad

Newidiadau i gynllun Stryd Wellington i ganiatâu i draffig deithio ddwyffordd ar hyd y stryd yn ei chyfanrwydd, i adeiladu mynedfa newydd i gerbydau yn siop Tesco ac i ddarparu ardal droi ym mhen dwyreiniol Stryd Wellington, yn unol â'r caniatâd cynllunio a roddwyd o dan Ran 3 o Ddeddf 1990 gan y Cyngor ar 11 Gorffennaf 2018 o dan y cyfeirnod 2018/1125/FUL.

SCHEDULE 4

Description of the new private means of access to be provided under this Order

A new private means of access located on the south side of Wellington Street, Swansea opposite the Multi-storey Car park, with a maximum length of 13 metres and a maximum width of 10 metres and shown by light diagonal hatching on the deposited plan.

A new private means of access located on the north side of the eastern end of Wellington Street, Swansea opposite the Multi-storey Car park, with a maximum length of 24 metres and a maximum width of 5 metres and shown by light diagonal hatching on the deposited plan.

SCHEDULE 5

The Development

Amendments to the layout of Wellington Street to allow two-way traffic flow along its entire length, the construction of a new vehicular access at the Tesco store and the provision of a turning area at the eastern end of Wellington Street, in accordance with planning permission granted under Part 3 of the 1990 Act by the Council on 11 July 2018 under reference number 2018/1125/FUL.
