

**ADDASU CYNLLUN YMDDIRIEDOLAETH  
ELUSEN TASKER MILWARD AND PICTON**

Mae Gweinidogion Cymru, drwy arfer y pŵer yn adran 82(1) o Ddeddf Safonau a Fframwaith Ysgolion 1998, yn gwneud y Gorchymyn a ganlyn i addasu cynllun ymddiriedolaeth Tasker Milward and Picton Charity (elusen gofrestredig rhif 525678) (“yr Elusen”) dyddiedig 17 Tachwedd 1983 (“y Cynllun”).

Cyn gwneud y Gorchymyn hwn mae Gweinidogion Cymru wedi ymgynghori, yn unol ag adran 82(2) o Ddeddf Safonau a Fframwaith Ysgolion 1998, â'r personau a ganlyn—

- (i) Ymddiriedolwyr yr Elusen; a
- (ii) corff llywodraethu'r ysgol.

O 1 Medi 2018 ymlaen, bydd y Cynllun wedi ei addasu fel a ganlyn—

**1. Diffiniadau**

Yn y Gorchymyn hwn—

ystyr “Elusen” (“*Charity*”) yw'r elusen a nodir ym mhennawd y Gorchymyn fel y'i llywodraethir gan y Cynllun;

ystyr “Ymddiriedolwyr” (“*Trustees*”) yw ymddiriedolwyr yr Elusen sy'n gweithredu o dan y Cynllun.

**2. Gweinyddu**

Caiff yr Elusen ei gweinyddu yn unol â'r Cynllun, fel y'i haddesir gan y Gorchymyn hwn.

**3. Addasu'r Cynllun**

- (i) Yn lle paragraff 3(2) o'r Cynllun rhodder—

“(2) The Trustees shall be appointed by the Governors of the school of the Charity.

Each appointment shall be made for a term of four years at a meeting convened and held according to the ordinary practice of the appointing body. The chairman of the meeting shall cause the name of each person appointed to be notified forthwith to the Trustees or their clerk. The person appointed may be but need not be a member of the appointing body.”

(ii) Hepgorer paragraff 4.

(iii) Yn lle paragraff 16 o'r Cynllun rhodder—

“16. The School. - The school of the Charity Haverfordwest High V.C. School shall be a school conducted as a voluntary controlled school.”

(iv) Yn lle paragraff 18 o'r Cynllun rhodder—

“18. Use of property. - The property numbered 1, 2 and 3 in the schedule to this Scheme shall be appropriated and used by the Trustees for the purposes of the school of the Charity together with any other property transferred by the local authority to the Trustees pursuant to paragraph 7(2) of Schedule 3 to the School Standards and Organisation (Wales) Act 2013 for the purposes of the school.”

(v) Yn lle paragraff 22 o'r Cynllun rhodder—

“22. Application of income. - Subject to payment of the

expenses aforesaid the Trustees shall apply the income of the Charity in either or both the following ways:-

- (1) in providing special benefits of any kind not normally provided by the local authority for the school of the Charity;
- (2) in promoting the education, including social and physical training, in such ways as they think fit of persons under the age of 25 years who are attending the school of the Charity, or who have at any time attended either the said school or the former Tasker Milward School or former Sir Thomas Picton School."

(vi) Ar ôl paragraff 25 o'r Cynllun mewnosoder—

"26. Disposal of certain Land. - The Trustees shall transfer to the local authority any land transferred to the Trustees pursuant to paragraph 7(2) of Schedule 3 to the School Standards and Organisation (Wales) Act 2013 for the purposes of the school pursuant to paragraph 18 above and which is no longer required for the purposes of the school of the Charity on the basis of a consideration calculated by reference to the provisions set out in paragraph 3(4) of Schedule 22 to the School Standards and Framework Act 1998."
