Mae Gweinidogion Cymru, drwy arfer y pwerau a rodir gan adrannau 12, 14, 125 a 268 o Ddeddf Prifyrdd 1980(1), ("Deddf 1980") yn gwneud y Gorchymyn hwn.

Enwi, Dehongli a Chychwyn

1. Daw'r Gorchymyn hwn i rym ar Ebrill 2019 a'i enw yw Gorchymyn Cefnffordd Castell-nedd i'r Fenni (yr A465) (Deuoli o'r Fenni i Hirwaun a'r Ffyrdd Ymuno ac Ymadael) a Chefnffordd Man i'r Dwyrain o Abercynon i Fan i'r Dwyrain o Ddowlais (yr A4060) a Chefnffordd Caerdydd i Lansanffraid Glan Conwy (yr A470) (Ffyrdd Cysylltu) (Dowlais Top i Hirwaun) (Ffyrdd Ymyl) 2019.

2. Yn y Gorchymyn hwn:-

(1) caiff pob mesuriad pellter ei fesur ar hyd llwybr y briffordd berthnasol neu'r fynedfa berthnasol i fangre, yn ôl y digwydd;

The Welsh Ministers, in exercise of powers conferred by sections 12, 14, 125 and 268 of the Highways Act 1980 (1) ("the 1980 Act") make this Order.

Title, Interpretation and Commencement

1. This Order shall come into force on April 2019 and its title will be "The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060) and Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) (Dowlais Top to Hirwaun) (Side Roads) Order 2019".

2. In this Order:-

(1) all measurements of distance are measured along the route of the relevant highway or means of access to premises as the case may be;

(1) 1980 p. 66: diwygiwyd adran 125(1) gan adran 4 o Ddeddf Cynllunio (Darpariaethau Canlyniadol) 1990 (p. 11) a pharagraff 45(8)(a) o Atodlen 2 iddi. Yn rhinwedd erthygl 2 o O.S. 1999/672 ac Atodlen 1 iddo, a pharagraff 30 o Atodlen 11 i Ddeddf Llywodraeth Cymru 2006, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

(1) 1980 c.66: section 125(1) was amended by the Planning (Consequential Provisions) Act 1990 (c.11), s.4, Sch. 2 para. 45(8)(a). By virtue of S.I.1999/672, article 2 and Schedule 1 and paragraph 30 of Schedule 11 to the Government of Wales Act 2006, these powers are now exercisable by the Welsh Ministers in relation to Wales.

(2) (i.) ystyr “ffordd ddosbarthiadol” (“*classified road*”), fel dosbarthiad i briffordd newydd, yw nad yw'r briffordd yn brif ffordd at ddibenion deddfiadau neu offerynnau sy'n cyfeirio at briffyrd a ddosbarthwyd yn brif ffyrdd ond ei bod yn ffordd ddosbarthiadol at ddibenion pob deddfiad ac offeryn sy'n cyfeirio at briffyrd a ddosbarthwyd gan Weinidogion Cymru ac nad yw'n cyfeirio'n benodol at eu dosbarthiad yn brif ffyrdd;

(ii) mae “gwella” (“*improvement*”) mewn perthynas â phrifffordd yn cynnwys codi, gostwng neu newid y briffordd honno mewn modd arall, a rhaid dehongli “sydd i'w gwella” (“*improved*”) yn unol â hynny;

(iii.) ystyr “prifffordd newydd” (“*new highway*”) yw prifffordd y mae'r Gorchymyn hwn yn awdurdodi ei hadeiladu, a rhaid dehongli “priffyrd newydd” (“*new highways*”) yn unol â hynny;

(iv.) ystyr “prif ffordd” (“*principal road*”) fel dosbarth ar gyfer prifffordd newydd yw bod y briffordd yn brif ffordd at ddibenion deddfiadau neu offerynnau sy'n cyfeirio at briffyrd a ddosberthir yn brif ffyrdd a'i bod hefyd yn ffordd ddosbarthiadol at ddibenion pob deddfiad ac offeryn arall sy'n cyfeirio at briffyrd a ddosberthir gan Weinidogion Cymru;

(v.) ystyr “y plan a adneuwyd” (“*the deposited plan*”) yw'r planiau safle sydd wedi eu rhifo 1 i 15 ac a geir yn y ffolio planiau sy'n dwyn y rhif HA/14/1 WG17 ac sydd wedi ei farcio “Gorchymyn Cefnffordd Castell-nedd i'r Fenni (yr A465) (Deuoli o'r Fenni i Hirwaun a'r Ffyrdd Ymuno ac Ymadael) a Chefnffordd Man i'r Dwyrain o Abercynon i Fan i'r Dwyrain o Ddowlais (yr A4060) a Chefnffordd Caerdydd i Lansanffraidd Glan Conwy (yr A470) (Ffyrdd Cysylltu) (Dowlais Top i Hirwaun) (Ffyrdd Ymyl) 2019” a hwnnw'n blan a lofnodwyd ar ran Gweinidogion Cymru ac a adneuwyd (cyf. qA1283492) yn Llywodraeth Cymru, Yr Uned Gwybodaeth a Rheoli Cofnodion, Parc Cathays, Caerdydd;

(vi.) ystyr “y plan safle” (“*the site plan*”) yw un o'r planiau safle sydd wedi eu rhifo 1 i 15 a geir yn y ffolio planiau sy'n dwyn y rhif HA/14/1 WG17 ac y cyfeirir ato fel “y plan a adneuwyd” ym mharagraff (v) uchod o'r erthygl hon;

(2) (i.) “classified road” (“*ffordd ddosbarthiadol*”) as a classification for a new highway, means that the highway is not a principal road for the purposes of enactments or instruments which refer to highways classified as principal roads but is a classified road for the purpose of every enactment and instrument which refers to highways classified by the Welsh Ministers and which does not specifically refer to their classification as principal roads;

(ii) “improvement” (“*gwella*”) in relation to a highway includes raising, lowering or otherwise altering that highway and “improved” shall be construed accordingly;

(iii.) “new highway” (“*prifffordd newydd*”) means a highway authorised by this Order to be constructed, and “new highways” shall be construed accordingly;

(iv.) “principal road” (“*prif ffordd*”) as a classification for a new highway, means that the highway is a principal road for the purposes of enactments or instruments which refer to highways classified as principal roads and is also classified for the purpose of every other enactment and instrument which refers to highways classified by the Welsh Ministers;

(v.) “the deposited plan” (“*y plan a adneuwyd*”) means the site plans numbered 1 to 15 contained in the plan folio numbered HA/14/1 WG17 and marked “The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060) and Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) (Dowlais Top to Hirwaun) (Side Roads) Order 2019” signed on behalf of the Welsh Ministers and deposited (ref:qA1283492) at the Welsh Government, Information and Records Management Unit, Cathays Park, Cardiff;

(vi.) “the site plan” (“*y plan safle*”) means one of the site plans numbered 1 to 15 contained in the plan folio numbered HA/14/1 WG17 and referred to as “the deposited plan” at paragraph (v.) above of this Article;

(vii.) “the trunk road (A465)” (“*y gefnffordd*”) means the Neath to Abergavenny Trunk Road (A465);

(vii.) ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd Castell-nedd i’r Fenni (yr A465);

(ix.) ystyr “ffordd ddiddosbarth” (“*unclassified road*”) yw prifffordd nad yw’n brif ffordd nac yn ffordd ddosbarthiadol nac yn llwybr troed nac yn llwybr beicio nac yn llwybr cefylau nac yn gilffordd gyfngedig ac nad oes iddi unrhyw ddosbarthiad ffurfiol.

Y Gwaith Awdurdodedig

3. Awdurdodir Gweinidogion Cymru, mewn perthynas â Chefnffordd yr A465 rhwng Hirwaun a Dowlais Top ym Mwrdeistrefi Sirol Merthyr Tudful, Rhondda Cynon Taf a Chaerffili:

(viii.) “the new trunk road” (“*y gefnffordd newydd*”) means the trunk road to be constructed in pursuance of The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060), Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 ⁽²⁾ as amended by The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060) and Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 (Brynmawr to Tredegar) (Amendment) Order 2012 ⁽³⁾ and as amended by The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060), Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 (Gilwern to Brynmawr) Amendment Order 2014 ⁽⁴⁾ and as further amended by the “The Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060), Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 (Dowlais Top to Hirwaun) (Amendment) Order 2019; and

(ix.) “unclassified road” (“*ffordd ddiddosbarth*”) means a highway that is not a principal road or a classified road or a footpath or a cycle track or a bridleway or a restricted byway and has no formal classification;

The Authorised Works

3. The Welsh Ministers are authorised, in relation to the A465 Trunk Road between Hirwaun and Dowlais Top in the County Boroughs of Merthyr Tydfil, Rhondda Cynon Taf and Caerphilly to:

- a. i wneud y gwaith i wella priffyrdd;
 - b. i gau priffyrdd neu rannau o briffyrdd;
 - c. i adeiladu priffyrdd newydd;
 - d. i gau mynedfeydd preifat i fangreodd;
 - e. i ddarparu mynedfeydd newydd i fangreodd;
 - f. i adeiladu darnau o briffordd dros dro; ac
 - g. i gau priffyrdd dros dro.
- a. carry out the improvement of highways;
 - b. stop up highways or areas of highways;
 - c. construct new highways;
 - d. stop up private means of access to premises,
 - e. provide new means of access to premises,
 - f. construct temporarily lengths of highway, and
 - g. close lengths of highway temporarily.

4. (1) Mae'r gwaith a awdurdodir gan erthygl 3 wedi ei ddangos yn Atodlenni 1 i 15 i'r Gorchymyn hwn ac wedi ei ddangos ar y planiau safle sy'n dwyn y rhifau 1 i 15 a gynhwysir yn y plan a adneuwyd ac sy'n cyd-fynd â'r Gorchymyn hwn fel a ganlyn:

- a. enwir y priffyrdd sydd i'w gwella yn yr Atodlenni ac fe'u dangosir â chroeslinellau ar y plan a adneuwyd;
 - b. disgrifir y darnau a'r rhannu o briffyrdd sydd i'w cau yn yr Atodlenni (bras amcan yn unig yw pob pellter a nodir) ac fe'u dangosir â llinellau sebra ar y plan a adneuwyd;
 - c. dangosir y priffyrdd newydd sydd i'w hadeiladu drwy ddefnyddio llythrennau cyfeirnod yn yr Atodlenni, a roddir i'r priffyrdd newydd hynny ar y plan a adneuwyd. Pan fo priffordd newydd i'w hadeiladu mewn cysylltiad â chau darn neu ran o briffordd a ddisgrifir mewn Atodlen, gosodir ei llythren gyfeirnod gyferbyn â'r disgrifiad o'r darn hwnnw neu'r rhan honno, a phan fo priffordd newydd i fod yn llwybr troed, yn llwybr beicio neu'n llwybr ceffylau, gwelir y geiriau "llwybr troed" neu "llwybr beicio" neu "llwybr ceffylau" (yn ôl y digwydd) mewn cromfachau o dan y llythren gyfeirnod. Dangosir llwybrau priffyrdd newydd sydd i'w hadeiladu â dotwaith a dangosir llinell ganol pob priffordd newydd â llinell ddu ddi-dor ar y plan a adneuwyd;
 - d. disgrifir y darnau o fynedfeydd preifat sydd i'w cau yn yr Atodlenni (bras amcan yn unig yw pob pellter a nodir), a rhoddir y rhifau cyfeirnod a ddangosir ar y plan a adneuwyd iddynt ac fe'u dangosir â bandiau du solet;
- a. highways to be improved are named in the Schedules and are shown by cross hatching on the deposited plan;
 - b. lengths and areas of highways to be stopped up are described in the Schedules (all distances stated being approximate only) and are shown by zebra hatching on the deposited plan;
 - c. new highways to be constructed are indicated by the use of reference letters in the Schedules which are given to those new highways on the deposited plan. Where a new highway is to be constructed in connection with the stopping up of a length or an area of highway described in a Schedule, its reference letter is placed opposite to the description of that length or area and, where a new highway is to be a footpath or cycleway or bridleway, the word "footpath" or "cycleway" or "bridleway" (as the case may be) appears in brackets beneath the reference letter. Routes of new highways to be constructed are shown by stipple and the centre line of each new highway is shown by an unbroken black line on the deposited plan;
 - d. lengths of private means of access to be stopped up are described in the Schedules (all distances stated being approximate only), and are given the reference numbers shown on the deposited plan and are shown by solid

- e. nodir y mynedfeydd preifat newydd sydd i'w darparu drwy ddefnyddio rhifau a llythrennau cyfeirnod yn yr Atodleni a roddir i'r mynedfeydd newydd hynny ar y plan a adneuwyd. Pan fo mynedfa breifat newydd i'w darparu mewn cysylltiad â chau darn o fynedfa breifat a ddisgrifir yn yr Atodlen honno, gosodir ei rhif a'i llythyren gyfeirnod gyferbyn â'r disgrifiad o'r darn hwnnw. (2) Mae'r plan a adneuwyd yn nodi safle'r gefnffordd a llwybr y gefnffordd newydd mewn perthynas â'r gwaith awdurdodedig a ddangosir ar y plan a adneuwyd.

(3) Pan fo darn o briffordd sydd i'w gau yn cyd-fynd â llwybr gwaith awdurdodedig sy'n briffordd newydd neu'n fynedfa newydd, ni ddangosir y darn hwnnw ar y plan a adneuwyd â llinellau sebra.

Cau Priffyrdd a Mynedfeydd Preifat

5. Datgenir drwy hyn fod Gweinidogion Cymru wedi eu bodloni:-

(1) o ran pob darn o briffordd y mae'r Gorchymyn hwn yn awdurdodi ei gau, naill ai fod llwybr rhesymol gyfleus arall ar gael neu y bydd yn cael ei ddarparu cyn i'r darn hwnnw o briffordd gael ei gau; a

(2) o ran pob mynedfa breifat i fangre y mae'r Gorchymyn hwn yn awdurdodi ei chau, fod mynedfa resymol gyfleus arall i'r fangre ar gael neu y bydd yn cael ei darparu cyn i'r fynedfa breifat honno gael ei chau neu nad oes angen rhesymol am fynedfa i'r fangre berthnasol.

black bands;

- e. new private means of access to be provided are indicated by the use of reference numbers and letters in the Schedules which are given to those new means of access on the deposited plan. Where a new private means of access is to be provided in connection with the stopping up of a length of private means of access described in that Schedule, its reference number and letter is placed opposite to the description of that length. Routes of new means of access to be provided are shown by diagonal hatching on the deposited plan.
- f. lengths of highway to be provided temporarily are shown by thin chevron hatching and the centre line of the temporary highways is shown by an unbroken black line on the deposited plan and are indicated by the use of reference numbers and letters in the Schedules; and
- g. lengths of highway to be closed temporarily are described (all distances being approximate only) and are shown by bold chevron hatching on the deposited plan and are indicated by the use of reference numbers and letters in the Schedules.

(2) The deposited plan marks the position of the trunk road and the route of the new trunk road in relation to the authorised works shown on the deposited plan.

(3) Where the area of a highway to be stopped up coincides with the route of an authorised work consisting of a new highway or a new means of access that area is not shown on the deposited plan by zebra hatching.

Stopping Up of Highways and Private Means of Access

5. It is hereby declared that the Welsh Ministers are satisfied:-

(1) as respects each length of highway the stopping up of which is authorised by this Order, that either another reasonably convenient route is available or will be provided before that length of highway is stopped up; and

Trosglwyddo Prifyrdd Newydd (i awdurdod prifyrdd)

6. Mae pob priffordd newydd i'w throsglwyddo i Gyngor Bwrdeistref Sirol Merthyr Tudful, Cyngor Bwrdeistref Sirol Rhondda Cynon Taf a Chyngor Bwrdeistref Sirol Caerffili fel y'i nodir yn yr Atodleni i'r Gorchymyn hwn, o'r dyddiad y bydd Gweinidogion Cymru yn hysbysu pob Cyngor ei bod wedi ei chwblhau a'i bod ar agor i draffig trwodd.

7. Yn union ar ôl trosglwyddo priffordd newydd caiff y briffordd honno ei dosbarthu yn briodol. Nodir dosbarthiad pob un o'r prifyrdd newydd yn yr Atoden i'r Gorchymyn hwn.

8. Pan fo darpariaeth yn cael ei gwneud yn y Gorchymyn hwn:-

- a. i drosglwyddo priffordd newydd i Gyngor Bwrdeistref Sirol Merthyr Tudful neu Gyngor Bwrdeistref Sirol Rhondda Cynon Taf neu Gyngor Bwrdeistref Sirol Caerffili; neu
- b. i alluogi Gweinidogion Cymru i newid priffordd a freiniwyd yn Siroedd Cyngor Bwrdeistref Sirol Merthyr Tudful, Cyngor Bwrdeistref Sirol Rhondda Cynon Taf a Chyngor Bwrdeistref Sirol Caerffili;

trosglwyddir i Gyngor Bwrdeistref Sirol Merthyr Tudful neu Gyngor Bwrdeistref Sirol Rhondda Cynon Taf neu Gyngor Bwrdeistref Sirol Caerffili, yn ddarostyngedig i ddarpariaethau adran 268(3) o Ddeddf 1980, ar y dyddiad y trosglwyddir y briffordd newydd neu adeg cwbllhau'r gwaith neu'r newid, neu ar ddyddiad caffael y tir gan Weinidogion Cymru mewn cysylltiad â'r briffordd newydd neu â newid priffordd, os bydd hynny'n ddiweddarach, unrhyw eiddo, hawliau neu rwymedigaethau (heblaw benthyciadau neu ffioedd am fenthyciadau) a freiniwyd yng Ngweinidogion Cymru neu a ysgwyddwyd ganddynt mewn cysylltiad â'r briffordd newydd neu â newid priffordd, yn ôl y digwydd.

Ymgymerwyr Statudol a Darparwyr

9. Pan fo gan ymgymerwyr statudol, yn union cyn cau darn o briffordd yn unol â'r Gorchymyn hwn, unrhyw gyfarpar o dan y briffordd honno,

(2) as respects each private means of access to premises the stopping up of which is authorised by this Order, that other reasonably convenient means of access to premises is available or will be provided before that private means of access is stopped up or that no access to the relevant premises is reasonably required.

Transfer of New Highways (to highway authority)

6. Each new highway is to be transferred to Merthyr Tydfil County Borough Council, Rhondda Cynon Taf County Borough Council and Caerphilly County Borough Council as indicated in the Schedules to this Order, as from the date when the Welsh Ministers notify each Council that it has been completed and is open for through traffic.

7. Immediately after the transfer of a new highway, that highway will be classified accordingly. The classification of each new highway is set out in the Schedule to this Order.

8. Where provision is made in this Order:-

- a. for the transfer of a new highway to Merthyr Tydfil County Borough Council or Rhondda Cynon Taf County Borough Council or Caerphilly County Borough Council; or
- b. for enabling the Welsh Ministers to alter a highway vested in in the Counties of Merthyr Tydfil County Borough Council, Rhondda Cynon Taf County Borough Council and Caerphilly County Borough Council;

there will be, subject to the provisions of Section 268(3) of the 1980 Act, transferred to Merthyr Tydfil County Borough Council or Rhondda Cynon Taf County Borough Council or Caerphilly County Borough Council on the date of transfer of the new highway or on completion of the works or alteration, or on the date of acquisition of the land by the Welsh Ministers in connection with the new highway or the alteration of a highway, if later, any property, rights or liabilities (other than loans or loan charges) vested in or incurred by the Welsh Ministers in connection with the new highway or the alteration of a highway, as the case may be.

2. In this Order:-

(1) all measurements of distance are measured along the route of the relevant highway or means of access to premises as the case may be;
