Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 3) Directions 2014

Made

30 September 2014

Coming into force in accordance with direction 1(3)

The Welsh Ministers in exercise of the powers conferred on them by sections 45, 203(9) and (10) and 204(1) of the National Health Service (Wales) Act 2006(1), and after consulting in accordance with section 45(4) of that Act with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate, give the following Directions:

Title, commencement and application

- 1.—(1) The title of these Directions is the Directions to Local Health Boards as to the Statement of Financial Entitlements (Amendment) (No. 3) Directions 2014.
 - (2) These Directions are given to Local Health Boards and apply in relation to Wales.
 - (3) The provisions of these Directions come into force as provided for in the following subparagraphs-
 - (a) direction 1, immediately after these directions are signed;
 - (b) directions 2, 3, 4, 5 and 7, on 1 October 2014; and
 - (c) directions 6 and 8, on 1 April 2015.

Amendments to the Statement of Financial Entitlements

2. The Directions to Local Health Boards as to the Statement of Financial Entitlements(**2**) which came into force on 11 June 2013, as amended by the Directions set out in the Schedule to these Directions, are further amended as follows.

Amendment of Section 2 – Global Sum Payments

- 3. Section 2 (Global Sum Payments) is amended as follows:
- (a) in paragraph 2.3, after the figure "£71.56" insert "for the period 1 April to 30 September 2014. For the period 1 October 2014 to 31 March 2015, the resulting figure is to be multiplied by £69.78. From 1 April 2015, the resulting figure which is the contractor's Weighted Population for the quarter, is to be multiplied by £70.67".

Amendment of Section 3 – Minimum Practice Income Guarantee

4. Section 3 (Minimum Practice Income Guarantee) is amended as follows:

"Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1 April 2014 and ending 30 September 2014

- 3.17A. In respect of the period commencing on 1 April 2014 and ending on 30 September 2014, the LHB must review the baseline monthly figure amount in respect of a contractor's CFMP (which is the monthly figure for any CFMP that was payable at the end of the previous financial year) and uprate that amount by 4.8% which is the percentage by which the first amount specified in paragraph 2.3 is uprated for the start of the financial year";
- (b) After 3.17A, insert the following -

"Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1 October 2014 and ending 31 March 2015

3.17B. In respect of the period commencing on 1 October 2014 and ending on 31 March 2015 the LHB must review the baseline monthly figure amount in respect of a contractor's CFMP (which is the monthly figure for any CFMP that was payable at the end of the previous financial year) and uprate that amount by 2.2% which is the percentage by which the second amount specified in paragraph 2.3 is uprated for the period 1October 2014 to 31 March 2015";

"Review and revision of the baseline monthly figure amount for Correction Factor Monthly Payments in respect of the period 1 April 2015 and ending 31 March 2016

3.17C. In respect of the period commencing on 1 April 2015 and ending on 31 March 2016, the LHB must review the baseline monthly figure amount in respect of a contractor's CFMP (which is the monthly figure for any CFMP that was payable at the end of the previous financial year) and uprate that amount by 3.51% which is the percentage by which the third amount specified in paragraph 2.3 is uprated for the start of the financial year";

Amendment to Part 2 of Annex G to apply from 1 October 2014 up to and including 31 March 2015
