The Welsh Ministers in exercise of the powers conferred on them by sections 66(4) and (5), 203(9) and (10), and 204(1) of the National Health Service (Wales) Act 2006(1), after consulting in accordance with section 60(4) of that Act both with the bodies appearing to them to be representative of persons to whose remuneration these Directions relate and with such other persons as they consider to be appropriate, give the following Directions:

Title, commencement and interpretation

1.—(1) The title of these Directions is the Directions to Local Health Boards as to the Personal Dental Services Statement of Financial Entitlements (Amendment) Directions 2013.

(2) These Directions come into force on 10 May 2013 and have effect from 1 April 2013.

(3) In these Directions, “the 2009 Directions”, means the directions given by the Welsh Ministers to Local Health Boards as to the Personal Dental Services Statement of Financial Entitlements 2009(2).

Amendments to the Statement of Financial Entitlements


2. In section 2 (Negotiated Annual Agreement Values) of the 2009 Directions, for paragraph 2.10 substitute:-

“2.10 The percentage determined by the Welsh Ministers for the financial year commencing on 1 April 2012 is 1.5%”

- (1) The title of these Directions is the Directions to Local Health Boards as to the Personal Dental Services Statement of Financial Expenditure (Amendment) Directions 2013.
 - (2) These Directions come into force on 10 May 2013 and have effect from 1 April 2013.
 - (3) In these Directions, the term "Directors" means the directors given by the Welsh Ministers to Local Health Boards as to the Personal Dental Services Statement of Financial Expenditure (Amendment) Directions 2013.

Amendment to the Statement of Financial Expenditure

1. In section 2 (General Annual Agreement) of the 2006 Directions, for paragraph 1.10 the following paragraph is substituted:

1.10 The percentage identified by the Welsh Ministers for the financial year commencing on 1 April 2013 is 1.5%.
