Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A40 Abertawe i Fanceinion, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A40 Swansea to Manchester Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddwyd iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A40 (Croesfan Reilffordd Llanymddyfri, Llanymddyfri, Sir Gaerfyrddin) (Gwahardd Cerbydau Dros Dro) 2018 a daw i rym ar 9 Ebrill 2018.

1. The title of this Order is the A40 Trunk Road (Llandoverly Level Crossing, Llandoverly, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 9 April 2018.

2.—(1) Yn y Gorchymyn hwn:

ystyr "cerbyd esempt" ("*exempted vehicle*") yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

ystyr "cyfnod y gwaith" ("*works period*") yw'r cyfnod hwnnw sy'n dechrau am 21:20 o'r gloch ar

2.—(1) In this Order:

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the trunk road" ("*y gefnffordd*") means the A40 Swansea to Manchester Trunk Road;

(2) Mae unrhyw gyfeiriad yn y Gorchymyn hwn at erthygl â rhif yn gyfeiriad at yr erthygl sy'n dwyn y rhif hwnnw yn y Gorchymyn hwn.

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, na pheri na chaniatáu i unrhyw gerbyd, ac eithrio cerbyd esempt, fynd ar y darn o'r gefnffordd yn Rhodfa Tywi, Llanymddyfri yn Sir Gaerfyrddin sy'n ymestyn o bwynt 20 o fetrau i'r gogledd o Groesfan Reilffordd Llanymddyfri hyd at bwynt 20 o fetrau i'r de o'r groesfan o dan sylw.

Cymhwyso

4. Ni fydd y gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

"works period" ("*cyfnod y gwaith*") means that period commencing at 21:20 hours on 9 April 2018 and ending when the temporary traffic signs have been permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the length of the trunk road at Tywi Avenue, Llandovery in the County of Carmarthenshire that extends from a point 20 metres north of Llandovery level crossing to a point 20 metres south of that level crossing.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order is 18 months.

(GWAHARDD CERBYDAU DROS DRO) 2018**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A40, neu gerllaw iddi, wrth groesfan reilffordd Llanymddyfri, Llanymddyfri, Sir Gaerfyrddin.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys ac ar gyfer y gwaith, rhag mynd ar y darn o'r A40 sy'n ymestyn am 20 o fetrau bob ochr i groesfan reilffordd Llanymddyfri yn Rhodfa Tywi, Llanymddyfri.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de fydd mynd ar yr A40 tua'r de-orllewin i Ashfield, ar yr A4069 tua'r dwyrain i Llangadog ac ar yr A4069 tua'r gogledd-ddwyrain i Lanymddyfri: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd.

Disgwylir y bydd y gwaharddiad, y codir arwyddion priodol yn ei gylch, yn dod i rym ar 9 Ebrill 2018 ac yn gweithredu dros nos (21:20 – 06:00 o'r gloch) hyd 11 Ebrill 2018 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall.

**THE A40 TRUNK ROAD (LLANDOVERY
LEVEL CROSSING, LLANDOVERY,
CARMARTHENSHIRE) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2018**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A40 trunk road at Llandovery level crossing, Llandovery, Carmarthenshire.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the length of the A40 that extends for 20 metres either side of Llandovery level crossing at Tywi Avenue, Llandovery.

The alternative route for southbound vehicles will be via the south-westbound A40 to Ashfield, the eastbound A4069 to Llangadog and the north-eastbound A4069 to Llandovery: vice versa for northbound vehicles.

It is expected that the prohibition, which will be signed accordingly, will come into force on 9 April 2018 and operate overnight (21:20 – 06:00 hours) until 11 April 2018 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required.
