Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A4042, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarn penodedig o'r gefnffordd oherwydd perygl tebygol i'r cyhoedd.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrd 1984(1), yn gwneud y Gorchymyn hwn.

Enwi, Cychwyn a Dehongli

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4042 (Cylchfan Edlogan Way, Croesyceiliog i Gylchfan Court Farm, Pont-y-pŵl, Torfaen) (Terfyn Cyflymder 50 mya Dros Dro) 2019 a daw i rym ar 3 Mai 2019.

2. Yn y Gorchymyn hwn:
ystyr "cerbyd esempt" ("exempted vehicle") yw:

(1) 1984 p.27; amnewidiwyd adran 14 gan Ddeddf Traffig Ffyrd (Cyfyngiadau Dros Dro) 1991 (p.26), adran 1(1) ac Atodlen 1. Yn rhinwedd O.S. 1999/672, ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

ROAD TRAFFIC, WALES

The A4042 Trunk Road (Edlogan Way Roundabout, Croesyceiliog to Court Farm Roundabout, Pontypool, Torfaen) (Temporary 50 mph Speed Limit) Order 2019

<i>Made</i>	<i>29 April 2019</i>
<i>Coming into force</i>	<i>3 May 2019</i>

The Welsh Ministers, as traffic authority for the relevant length of the A4042 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be restricted because of the likelihood of danger to the public.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A4042 Trunk Road (Edlogan Way Roundabout, Croesyceiliog to Court Farm Roundabout, Pontypool, Torfaen) (Temporary 50 mph Speed Limit) Order 2019 and it comes into force on 3 May 2019.

2. In this Order:

"exempted vehicle" ("cerbyd esempt") means:

(1) 1984 c.27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

- (a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(2); a
- (b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—

- (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
- (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr "y gefnffordd" ("the trunk road") yw Cefnffordd yr A4042 Casnewydd i Amwythig; ystyr "lluoedd arbennig" ("special forces") yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnwl eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfngiad

3. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 50 milltir yr awr ar y darn o'r gefnffordd sy'n ymestyn o'i chyffordd ag ochr ogledol Cylchfan Edlogan Way, Croesyceiliog i'w chyffordd ag ochr ddeheuol Cylchfan Court Farm, Pont-y-pŵl, Torfaen, gan gynnwys cerbytffyrrdd cylchredol Cylchfannau Cwmbrân a Phont-y-pŵl.

Cymhwysyo

4. Nid yw'r cyfngiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y mae arwyddion traffig yn eu dangos.

Atal Dros Dro

5. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darn o'r gefnffordd wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfngiad a bennir yn erthygl 3 yn weithredol.

(2) Diwygiwyd adran 87 gan baragraff 55 o Atodlen 1 i Ddeddf Gwasanaethau Tân ac Achub 2004 (p.21), paragraff 42 o Atodlen 4 i Ddeddf Troseddu Cyfundrefnol Difrifol a'r Heddlu 2005 (p.15), paragraff 29(2) o Atodlen 8 i Ddeddf Troseddu a'r Llysoedd 2013 (p.22) ac adran 50(4) a (5) o Ddeddf Dadreoleiddio 2015 (p.20).

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

"special forces" ("lluoedd arbennig") means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

"the trunk road" means the A4042 Newport to Shrewsbury Trunk Road.

Restriction

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the length of the trunk road that extends from its junction with the northern side of Edlogan Way Roundabout, Croesyceiliog to its junction with the southern side of Court Farm Roundabout, Pontypool, Torfaen, including the circulatory carriageways of Cwmbran and Pontypool Roundabouts.

Application

4. The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

Suspension

5. Any statutory provisions restricting the speed of vehicles on the length of the trunk road are suspended during such times as the restriction specified in article 3 is in operation.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c.21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c.15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c.22), Schedule 8, paragraph 29(2) and the Deregulation Act 2015 (c.20), section 50(4) and (5).

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn oherwydd perygl tebygol i'r cyhoedd ar gefnffordd yr A4042 rhwng Croesyceiliog a Phont-y-pwl, Torfaen.

**THE A4042 TRUNK ROAD (EDLOGAN WAY
ROUNDAABOUT, CROESYCEILIOG TO COURT
FARM ROUNDAABOUT, PONTYPOOL,
TORFAEN) (TEMPORARY 50 MPH SPEED
LIMIT) ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary due to the likelihood of danger to the public on the A4042 trunk road between Croesyceiliog and Pontypool, Torfaen.

The effect of the Order is to impose a temporary 50 mph speed limit on the length of the A4042 trunk road that extends from its junction with the northern side of Edlogan Way Roundabout, Croesyceiliog to its junction with the southern side of Court Farm Roundabout, Pontypool, including the circulatory carriageways of Cwmbran and Pontypool Roundabouts.

The Order is expected to come into force on 3 May 2019 and operate for a maximum duration of 18 months.
