Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer Cefnffordd yr A470, wedi eu bodloni y dylid gwahardd traffig a/neu gyfyngu arno ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A470 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be restricted and/or prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title, Commencement and Interpretation**

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Ffin Sirol Powys/Merthyr Tudful i Lanfair-ym-Muallt, Powys) (Cyfyngiadau Cyflymder Dros Dro a Dim Goddiweddyd) 2019 a daw i rym ar 18 Ionawr 2019.

1. The title of this Order is the A470 Trunk Road (Powys/Merthyr Tydfil County Boundary to Built Wells, Powys) (Temporary Speed Restrictions & No Overtaking) Order 2019 and it comes into force on 18 January 2019.

2. Yn y Gorchymyn hwn:

2. In this Order:

ystyr "cerbyd esempt" ("*exempted vehicle*") yw:

"exempted vehicle" ("*cerbyd esempt*") means:

(a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(2); a

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and

(1) 1984 p.27; amnewidiwyd adran 14 gan adran 1(1) o Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991 (p.26) ac Atodlen 1 iddi. Yn rhinwedd O.S. 1999/672, ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p.32) a pharagraff 30 o Atodlen 11 iddi, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

(1) 1984 c.27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c.21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c.15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c.22), Schedule 8, paragraph 29(2) and the Deregulation Act 2015 (c.20), section 50(4) and (5).

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—

(i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu

(ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol a fydd yn cychwyn am 08:00 o'r gloch ar 18 Ionawr 2019 ac a ddaw i ben pan fydd yr arwyddion traffig dros dro ar gyfer pob cyfnod o waith wedi eu symud ymaith;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A470 Caerdydd i Langurig sy'n ymestyn o ffin Sir Powys/Bwrdeistref Sirol Merthyr Tudful ym Mhont Llysiog hyd at ei chyffordd gylchfan â'r A483 yn Llanfair-ym-Muallt, Powys;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

### Cyfyngiadau a Gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 40 milltir yr awr ar y darn o'r gefnffordd.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 30 milltir yr awr ar y darn o'r gefnffordd.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 10 milltir yr awr ar y darn o'r gefnffordd.

6. Ni chaiff neb, yn ystod cyfnod y gwaith, ddefnyddio cerbyd na chaniatáu i gerbyd, ac eithrio cerbyd esempt, gael ei ddefnyddio yn y fath fodd fel ei fod yn goddiweddyd unrhyw gerbyd arall ar y darn o'r gefnffordd ar yr adegau hynny pan fo'r cyfyngiad yn erthygl 5 yn weithredol.

### Cymhwys

7.—(1) Ni fydd y cyfyngiadau a'r gwaharddiad yn erthyglau 3, 4, 5 a 6 yn gymwys ond ar yr adegau ac i'r graddau y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw terfynau cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A470 Cardiff to Llangurig Trunk Road that extends from the Powys County/Merthyr Tydfil County Borough boundary at Pont Llysiog to its roundabout junction with the A483 at Builth Wells, Powys;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 08:00 hours on 18 January 2019 and ending when the temporary traffic signs for each period of works are removed.

### Restrictions & Prohibition

3. No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the length of the trunk road.

4. No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the length of the trunk road.

5. No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the length of the trunk road.

6. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

### Application

7.—(1) The restrictions and prohibition in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

### **Atal Dros Dro**

8. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darn o'r gefnffordd wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiadau a bennir yn erthyglau 3, 4 a 5 yn weithredol.

### **Cyfnod Para'r Gorchymyn hwn**

9. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

### **Suspension**

9. The maximum duration of this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, rhwng ffin sirol Powys/Merthyr Tudful a Llanfair-ym-Muallt, Powys.

Effaith y Gorchymyn yw gosod terfyn cyflymder o 40 mya, 30 mya neu 10 mya ar y darn o gefnffordd yr A470 rhwng ffin sirol Powys/Merthyr Tudful ym Mhont Llysiog hyd at ei chyffordd gylchfan â'r A483 yn Llanfair-ym-Muallt. Dim ond yn ystod gwaith confoi y bydd y terfyn cyflymder o 10 mya yn weithredol a ni chaniateir goddiweddyd ar yr adegau hynny.

Disgwylir y bydd y cyfyngiadau a'r gwaharddiad, y bydd eu hyd a'u lled yn amrywio, yn weithredol yn ysbeidiol o 08:00 o'r gloch ar 18 Ionawr 2019 am gyfnod hwyaf o 18 mis. Bydd hysbysiad ymlaen llaw am y gwaith yn cael ei arddangos tua 2 wythnos cyn i unrhyw gwaith ddechrau.

**THE A470 TRUNK ROAD (POWYS/MERTHYR  
TYDFIL COUNTY BOUNDARY TO BUILTH  
WELLS, POWYS) (TEMPORARY SPEED  
RESTRICTIONS AND NO OVERTAKING)  
ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A470 trunk road between the Powys/Merthyr Tydfil county boundary and Builth Wells, Powys.

The effect of the Order is to temporarily impose a 40 mph, 30 mph or 10 mph speed limit on the length of the A470 trunk road between the Powys/Merthyr Tydfil county boundary at Pont Llysiog to its roundabout junction with the A483 at Builth Wells. The 10 mph speed limit will only apply during convoy working and no overtaking will be permitted during these times.

It is expected that the restrictions and prohibition, whose extent will vary, will be in force intermittently from 08:00 hours on 18 January 2019 for a maximum duration of 18 months. Advance notice of the works will be displayed approximately 2 weeks before the start of any works.
