## Capital Region Business Council – Why?

- The business voice needs to reflect the quickly evolving regional economic regeneration structures and infrastructure projects
- ➤ A voice to reflect ALL of South East Wales in equal measure
- > The more prosperous parts of the Region cannot dominate the agenda
- Business has many of the skills that the Region needs
- If the Region prospers, business prospers
- It is accepted by the UK and Welsh Governments and the Local Authorities that a strong, unified business voice is essential.
- It will need to exist in order to engage properly with the City Dealby November at the latest.
