NOTICE IS HEREBY GIVEN that the Welsh Ministers propose to make an Order under sections 1(1), 2(1) and (2), 84 (1) and (2) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to impose a 30 mph speed limit on those lengths of the A470 Cardiff - Llangurig Trunk Road specified in Schedule 1 to this notice and remove the existing prohibition of pedestrians from those lengths specified in Schedule 2.

During a period of 21 days from 19 July 2012, a copy of the proposed Order together with a plan and a Statement of Reasons for the making of the Order, may be inspected free of charge, during normal office hours at Pontypridd Library, Library Road, Pontypridd CF37 2DY or may be obtained free of charge from the address below.

Objections, specifying the grounds on which they are made, must be sent in writing to the Welsh Government, Orders Branch, Transport, Cathays Park, Cardiff CF10 3NQ by 09 August 2012. Please note: Should you wish to object, support or make representations, we may need to consult with people and organisations outside of the Welsh Government. As part of the process of consulting with others we may pass information to them, including information you have given us and your personal data. We will however, only disclose your personal details where it is necessary to do so to enable us to deal with issues you have brought to our attention.

The Welsh Ministers, as traffic authority for the A470 Cardiff – Llangurig Trunk Road (hereinafter referred to as “the trunk road”), in exercise of the powers conferred upon them by sections 1(1), 2(1) and (2), 84 (1) and (2) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1) (hereinafter referred to as “the 1984 Act”), and after consultation with the Chief Officer of the South Wales Police, hereby make the following Order:-

1. This Order comes into force on ***** 2012. The title to this Order is The A470 Trunk Road (Bridge Street Interchange, Pontypridd, Rhondda Cynon Taf) (30 MPH Speed Limit and Removal of Prohibition of Pedestrians) Order 201-.

2. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour in that length of the A470 Trunk Road specified in Schedule 1 to this Order.

3. The restriction imposed by this Order is in addition to and not in derogation from any restriction or requirement imposed by any Regulations made or having effect as if made under the 1984 Act or by or under any other enactment.

4. The Trunk Road (Glyntaff to Abercynon, Glamorgan) (Prohibition of Foot Passengers) Order 1973(2) is hereby revoked in respect of the lengths of the A470 Trunk Road specified in Schedule 2 to this Order.

STATEMENT OF REASONS

The proposed Order would relocate the existing 30 MPH speed limit and adjust the position of the current pedestrian prohibition, and is considered necessary in the interests of road safety to allow pedestrian movements between Pontypridd and the east side of the A470.
