Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer Cefnffordd yr A483 Abertawe i Fanceinion, drwy arfer y pwerau a roddir iddynt gan adrannau 84(1)(c), (1A) a (2) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), ac ar ôl ymgynghori â Phrif Swyddog Heddlu Dyfed-Powys, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, as traffic authority for the A483 Swansea to Manchester Trunk Road, in exercise of the powers conferred upon them by sections 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984(1) and after consultation with the Chief Officer of Dyfed Powys Police, make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A483 (Ffordd Tremont, Llandrindod) (Terfyn Cyflymder 20 mya Rhan-amser) 2018 a daw i rym ar 27 Ebrill 2018.

1. The title of this Order is the A483 Trunk Road (Tremont Road, Llandrindod Wells) (Part-time 20 mph Speed Limit) Order 2018 and it comes into force on 27 April 2018.

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw:

“exempted vehicle” (“*cerbyd esempt*”) means:

(a) unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(2);

(a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu

(ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A483 Abertawe i Fanceinion;

ystyr “lloedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lloedd arfog y mae Cyfarwyddwr y Lloedd Arbennig yn gyfrifol am gynnal eu galluedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiad

3. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach nag 20 milltir yr awr ar y darn o'r gefnffordd yn Ffordd Tremont, Llandrindod sy'n ymestyn o bwynt 66 o fetrau i'r gogledd-ddwyrain o ganolbwynt ei chyffordd â Brookland Road hyd at bwynt 141 o fetrau i'r de o ganolbwynt ei chyffordd â Lôn Trefonnen.

4. Nid yw'r cyfyngiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y mae arwyddion traffig yn eu dangos.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A483 Swansea to Manchester Trunk Road.

Restriction

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 20 miles per hour on the length of the trunk road at Tremont Road, Llandrindod Wells that extends from a point 66 metres north east of the centre-point of its junction with Brookland Road to a point 141 metres south of the centre-point of its junction with Trefonen Lane.

Application

4. The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

**THE A483 TRUNK ROAD (TREMONT ROAD,
LLANDRINDOD WELLS) (PART-TIME 20 MPH
SPEED LIMIT) ORDER 2018**

The Welsh Ministers have made an Order in exercise of their powers under section 84(1)(c), (1A) and (2) of the Road Traffic Regulation Act 1984, which comes into force on 27 April 2018.

The effect of the Order is to introduce a part-time 20 mph speed limit on the length of the A483 trunk road at Tremont Road, Llandrindod Wells that extends from a point 66 metres north east of the centre-point of its junction with Brookland Road to a point 141 metres south of the centre-point of its junction with Trefonnen Lane in order to reduce the speed of traffic and promote pedestrian safety near Llandrindod Wells Church in Wales Community Primary School Trefonnen. This reduced speed limit is only expected to apply for limited periods of the day during school term time.
