Item 1 - Joint Executive Committee (JEC) Shadow Status	Decisions	Members agreed the Joint Executive Committee (JEC) should now move formally out of shadow arrangements.
Item 2 - WPC Vision Document - Working Group Update to the WPC Vision Document Agreed 21 March 2019	Decisions	Members agreed a number of changes should be made to the draft WPC Vision Document and the Priorities for Action defined within it. These were:  WPC Vision – Martin Mansfield proposed an amendment to the vision which was accepted. Martin agreed to circulate the redrafted text.  WPC Mission – For the order under this section to be re-drafted so that priority 2. Contribute to Making Wales a Fair Work Nation is listed first and Workforce mobility listed last  Strategic Context – To replace the current proposed structure with a single paragraph to capture the key issues, offering a strategic context of no longer than 500 words. Issues to be included in the narrative include the wellbeing of future generations, European Transition, Austerity, One Public Service, Social Partnership Act and the increasing demand on public services. The context would make clear that it will evolve over time and is not static. Joint Secretariat to work with Welsh Government colleagues to draft the strategic context in line with current policy context and circulate to the JEC for approval.  Priority – Workforce Mobility - It was agreed that to "avoid redundancy" would be added to the ambition section for this priority.  Priority – Workforce Mobility - It was agreed the Welsh Government would make available the previous work of the WPC's Workforce Planning and Mobility Sub-group to the Joint Secretariat to include the mobility protocol.  Priority – Fair Work - It was agreed the first paragraph heading the Objectives would be placed at the foot of that section instead and

		that it would be amended to acknowledge the importance of the Fair Work Commission's recommendations but making clear that implementation of these is not part of the WPC's mandate. It was also agreed that this paragraph would make clear that any work in this area would be produced as living document(s) and adapted as appropriate in order to accommodate the emerging findings of the Fair Work Commission.  Priority – Integration and Equivalence – It was agreed this priority should be re-named Workforce Equity.
	Actions	It was agreed the Joint Secretariat would make

Item 4 - Asbestos and Public Buildings	Decisions	The JEC noted the seriousness of this issue and considered it could address the matter from a social partnership view in seeking to identify which groups were discussing asbestos, gaining an up to date picture.
	Actions	It was agreed the Joint Secretariat would now prepare a paper for the next meeting of the JEC identifying the different groups involved in discussing asbestos in public buildings. It was noted that expertise from the Welsh Government would be critical to this exercise.
