EXPLANATORY NOTE
(This note is not part of the Order)

The Order amends the Neath to Abergavenny Trunk Road (A465) (Abergavenny to Hirwaun Dualling and Slip Roads) and East of Abercynon to East of Dowlais Trunk Road (A4060), Cardiff to Glan Conwy Trunk Road (A470) (Connecting Roads) Order 1999 as amended by a 2012 Amendment Order, a 2014 Amendment Order and a 2019 Amendment Order, in respect of the length of the main new trunk road between Dowlais Top and Hirwaun (known as Sections 5 and 6); it also provides for some changes to junction arrangements including the amendment of new slip roads.

The 2012 Amendment Order amended the 1999 Order in respect of the lengths of the new trunk road (A465) between Brynmawr and Tredegar (known as Section 3). The 2014 Amendment Order amended the 1999 Order in respect of the lengths of the new trunk road (A465) between Gilwern and Brynmawr (known as Section 2). The 2019 Amendment Order amended the 1999 Order in respect of the lengths of the new trunk roads (A465 and A470) between Dowlais Top and Hirwaun (Sections 5 and 6). This Order further amends the 1999 Order in respect of the lengths of the new trunk roads (A465 and A470) between Dowlais Top and Hirwaun (Sections 5 and 6).

Articles 3, 4, 5 and 6 amend Schedule 2 to the amended 1999 Order in respect of Sections 5 and 6 by amending descriptions of slip roads to be provided.

4. In Schedule 2 to the Principal Order, in paragraph 20 replace references to "Site Plan 10A" with "Site Plan 10B" and delete the second and third sub-paragraphs and replace with—

A route some 805 metres in length commencing at a point on the westbound carriageway of the main new trunk road 281 metres east of the junction between the existing A465 trunk road and the road leading to the Jah Jireh Nursing Home, in a generally southwesterly direction to a point 524 metres south west of the junction between the existing A465 trunk road and the unclassified road leading to Croesbychan (on the circulatory carriageway of a new roundabout to be provided for in the associated side roads order) (the new trunk road along this route being given the reference number 60 on the deposited plan at Site Plan 10B (as amended)).

5. In Schedule 2 to the Principal Order, delete paragraph 21 and insert—

“21. Grade separated junction at Hirwaun Ponds (Site Plan 11B).

Four routes to connect the eastbound and westbound carriageways of the main new trunk road with two linked roundabouts to be constructed as part of the highway to be provided for in the associated side roads order, in the vicinity of the existing roundabout at Hirwaun Ponds (the new trunk roads along these routes being given the numbers 61, 62, 63 and 64 on the deposited plan at Site Plan 11B (as amended)).

A route some 478 metres in length commencing at a point on the westbound carriageway of the main new trunk road 89 metres west of the south west corner of the Hirwaun Recreational Ground, in a generally northwesterly direction to a point 109 metres south of the centre of Rhigos roundabout to join the circulatory carriageway of a new connecting road to be provided for in the associated side roads order (the new trunk road along this route being given the reference number 61 on the deposited plan at Site Plan 11B (as amended)).

A route some 462 metres in length commencing at a point 93 metres south west of the centre of Rhigos roundabout (on the circulatory carriageway of a new connecting road to be provided for in the associated side roads order) in a generally north westerly direction to join the westbound carriageway of the main new trunk road at a point 351 metres south east of Tower Sidings Bridge (the new trunk road along this route being given the reference number 62 on the deposited plan at Site Plan 11B (as amended)).

A route some 609 metres in length commencing at
