1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffyrrd yr A487 a'r A40 (Abergwaun, Sir Benfro) (Traffig Unffordd) 2020 a daw i rym ar 26 Tachwedd 2020.

ystyr “cefnffordd yr A487” (“the A487 trunk road”) yw cefnffordd yr A487 Abergwaun i Fangor;

ystyr “cefnffordd yr A40” (“the A40 trunk road”) yw cefnffordd yr A40 Llundain i Abergwaun; ac,

ystyr “ffordd gyswllt yr A487” (“the A487 link road”) yw ffordd gyswllt yr A487 (Heol Fawr A40 i'r Wesh A487), Abergwaun.

The A487 and A40 Trunk Roads (Fishguard, Pembrokeshire) (One Way Traffic) Order 2020

Made 24 November 2020
Coming into force 26 November 2020

The Welsh Ministers, as traffic authority for the A487 and A40 trunk roads, in exercise of the powers conferred upon them by sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984⁽¹⁾, after giving public notice of their intention to do so and after consultation with the Chief Officer of Dyfed-Powys Police, make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A487 and A40 Trunk Roads (Fishguard, Pembrokeshire) (One Way Traffic) Order 2020 and it comes into force on 26 November 2020.

2. In this Order:

“the A487 link road” (“ffordd gyswllt yr A487”) means the A487 (High Street A40 to West Street A487) Link Road, Fishguard;

“the A487 trunk road” (“cefnffordd yr A487”) means the A487 Fishguard to Bangor trunk road; and,

“the A40 trunk road” (“cefnffordd yr A40”) means the A40 London to Fishguard trunk road.

Prohibition

4. No person may cause or permit any vehicle to proceed in any direction other than south-westwards on the length of the A40 trunk road specified in Schedule 2 to this Order.
