Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o draffordd yr M4, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarnau penodedig o'r draffordd oherwydd y tebygolrwydd o berygl i'r cyhoedd neu o ddifrod difrifol i'r ffordd.

The Welsh Ministers, as traffic authority for the relevant length of the M4 motorway, are satisfied that traffic on specified lengths of the motorway should be restricted because of the likelihood of danger to the public or of serious damage to the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 45 (Ynysforgan) i Gyffordd 46 (Llangyfelach), Abertawe) (Terfyn Cyflymder 50 mya Dros Dro) 2020 a daw i rym ar 12 Rhagfyr 2020.

1. The title of this Order is the M4 Motorway (Junction 45 (Ynysforgan) to Junction 46 (Llangyfelach), Swansea) (Temporary 50 mph Speed Limit) Order 2020 and it comes into force on 12 December 2020.

2. Yn y Gorchymyn hwn—

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw:

“exempted vehicle” (“*cerbyd esempt*”) means:

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

- (a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(2); a
- (b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—
 - (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
 - (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y draffordd” (“*the motorway*”) yw'r darn o draffordd yr M4 Llundain i Dde Cymru sy'n ymestyn o bwynt 395 o fetrau i'r dwyrain o drwyniad y ffordd ymuno tua'r gorllewin wrth Gyffordd 45 (Ynysforgan) hyd at bwynt 227 o fetrau i'r gorllewin o drwyniad y ffordd ymuno tua'r dwyrain wrth Gyffordd 46 (Llangyfelach), gan gynnwys y darnau o'r ffordd ymuno tua'r gorllewin wrth Gyffordd 45 a'r ffordd ymuno tua'r dwyrain wrth Gyffordd 46;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiadau

3. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y darnau o'r draffordd.

Cymhwyso

4.—(1) Nid yw'r cyfyngiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfyn cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the motorway” (“*y draffordd*”) means the length of the M4 London to South Wales motorway that extends from a point 395 metres east of the nosing of the westbound entry slip road at Junction 45 (Ynysforgan) to a point 227 metres west of the nosing of the eastbound entry slip road at Junction 46 (Llangyfelach), including the lengths of the westbound entry slip road at Junction 45 and eastbound entry slip road at Junction 46.

Restrictions

3. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the motorway.

Application

4.—(1) The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

Atal Dros Dro

5. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau modur ar y darnau o'r draffordd a bennir yn erthygl 2 o'r Gorchymyn hwn wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiad a bennir yn erthygl 3 o'r Gorchymyn hwn yn gymwys.

6. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

Duration of this Order

6. The maximum duration of this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn sicrhau diogelwch defnyddwyr y ffordd hyd nes y gall rhwystr newydd ar y llain ganol gael ei osod ar draffordd yr M4 rhwng Cyffordd 45 (Ynysforgan) a Chyffordd 46 (Llangyfelach), Abertawe.

**THE M4 MOTORWAY (JUNCTION 45
(YNYSFORGAN) TO JUNCTION 46
(LLANGYFELACH), SWANSEA)
(TEMPORARY 50 MPH SPEED LIMIT) ORDER

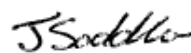
The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to ensure the safety of road users until the central reserve barrier can be replaced on the M4 motorway between Junction 45 (Ynysforgan) and Junction 46 (Llangyfelach), Swansea.

The effect of the Order is to impose a temporary 50 mph speed limit on the length of the M4 motorway that extends from a point 395 metres east of the nosing of the westbound entry slip road at Junction 45 to a point 227 metres west of the nosing of the eastbound entry slip road at Junction 46, including the lengths of the westbound entry slip road at Junction 45 and eastbound entry slip road at Junction 46.

The Order is expected to come into force at 00:01 hours on 12 December 2020 and to remain in force for a maximum duration of 18 months.
