# Distribution Sub-Group (2020) Paper 21 – Dataset collections impacted by Covid-19 update

This discussion paper has been written by officials of the Welsh Government. Ministers have not had an opportunity to comment on the contents. Exemplifications of changes are provided simply to inform discussion by DSG members. They are not Welsh Government proposals or statements of Government policy for or against changes.

### Impact of COVID-19 on settlement datasets

## **Summary**

1. This paper revisits the impact of the COVID-19 pandemic on settlement datasets. This paper is to advise which data collections have been able to go ahead, as well as a now updated list of those impacted by the pandemic.

# Views sought

 Members are asked to consider how to treat the indicators in the 2021-22 settlement, where they are impacted by the COVID-19 pandemic. The decisions required by the group are set out in the *analysis* section of this paper.

### **Background**

- 3. There are a number of datasets used in the settlement for which the collection of data which is due to be used in the 2021-22 settlement will, or could, be impacted by the COVID-19 pandemic.
- 4. In addition to this, there are a number of datasets where the data itself will, or could be, impacted by the COVID-19 pandemic.

- 5. A previous paper set out the issues impacting certain indicators which was presented at the July DSG meeting, a decision was made to update datasets when possible to do so, including setting up the non-PWLB and street lights data collections.
- 6. This paper provides an update on which datasets have been successfully collected so far, as well as any that have been impacted by the pandemic.

# **Analysis**

7. Table 1, below, lists the datasets used in the local government settlement and gives the current status where the collection of this data and/or the data itself may be impacted by the COVID-19 pandemic for the 2021-22 settlement.

## Planning applications

8. One local authority has not submitted an entry for one quarter of the planning applications data. If the data is not rectified, we can either use an average of the previous quarters' data as an estimated value or else treat it as a blank entry,

Views sought: If the data is not submitted, members' views are sought whether to use the published data as it is, or use an average of the previous three quarters.

#### **Tourism**

- 9. The tourism data is likely to be available to us in mid to late September. When the data is received it is likely to have been impacted by the Covid-19 pandemic and or could be incomplete.
- 10. The SSA unit for the enhanced population indicator was £58.48 in 2020-21 and the tourism part of this indicator accounted for the distribution of over £27 million of SSA, so there is potential for significant re-distribution, if this data were to be skewed in any way.

Views sought: Members' views are sought whether to freeze the data set if the data received is not considered to be robust enough.

### **PWLB** data

- 11. In calculating the pool rate we collect several data sources from the PWLB, including average rate of advances, borrowing figures and Wales's residual data. In previous years the PWLB provided us with the average rate of advances, and residual data not including HRA loans. Since last year they have moved to a new trading system with new reporting methods and are likely to no longer be able to provide us with the data excluding the HRA loans (this is unrelated to the COVID-19 pandemic).
- 12. The residual data is available online, but including HRA debt. Analysis on the effect of using this data for 2019 would have reduced the pool rate in 2020-21 from 6.7% to 5.8%.

Views sought: Members' views are sought on whether to use the PWLB data available (including the HRA loans) and, if the average rate of advances data is unavailable, to freeze this at last years' value.

### Conclusion

13. DSG members are asked to provide their recommendations, on the datasets considered. Further papers will be produced in the future, looking at the impact of covid-19 on data for settlements beyond 2021-22.
