Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o draffordd yr M4, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarnau penodedig o'r draffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the M4 motorway, are satisfied that traffic on specified lengths of the motorway should be restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 34 (Meisgyn), Rhondda Cynon Taf i Gyffordd 36 (Sarn), Pen-y-bont ar Ogwr) (Terfynau Cyflymder 40 mya a 50 mya Dros Dro) 2021 a daw i rym ar 1 Mawrth 2021.

1. The title of this Order is the M4 Motorway (Junction 34 (Miskin), Rhondda Cynon Taf to Junction 36 (Sarn), Bridgend) (Temporary 40 mph & 50 mph Speed Limits) Order 2021 and it comes into force on 1 March 2021.

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw:

“exempted vehicle” (“*cerbyd esempt*”) means:

(1) 1984 c.27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

- (b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—
 - (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
 - (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “y draffordd” (“*the motorway*”) yw traffordd yr M4 Llundain i Dde Cymru;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiadau

3. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 40 milltir yr awr ar y darnau o'r draffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

4. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y darnau o'r draffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

Cymhwyso

5.—(1) Nid yw'r cyfyngiadau yn erthyglau 3 a 4 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfynau cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the motorway” (“*y draffordd*”) means the M4 London to South Wales motorway.

Restrictions

3. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the motorway specified in the Schedule to this Order.

4. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the motorway specified in the Schedule to this Order.

Application

5.—(1) The restrictions in article 3 and 4 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

Atal Dros Dro

6. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau modur ar y darnau o'r draffordd a bennir yn yr Atodlen i'r Gorchymyn hwn wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiadau a bennir yn erthyglau 3 a 4 o'r Gorchymyn hwn yn weithredol.

7. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

**THE M4 MOTORWAY (JUNCTION 34
(MISKIN), RHONDDA CYNON TAF TO
JUNCTION 36 (SARN), BRIDGEND)
(TEMPORARY 40 MPH & 50 MPH SPEED
LIMITS) ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the M4 motorway between Junction 34 (Miskin), Rhondda Cynon Taf and Junction 36 (Sarn), Bridgend.

The effect of the Order is to impose a temporary 40 mph and/or 50 mph speed limit on:

- i. the length of the M4 westbound carriageway that extends from the nosing of the westbound exit slip road at Junction 34 (Miskin) to the nosing of the westbound entry slip road at Junction 36 (Sarn); and
- ii. the length of the M4 eastbound carriageway that extends from the nosing of the eastbound exit slip road at Junction 36 (Sarn) to the nosing of the eastbound entry slip road at Junction 34 (Miskin).

The Order comes into force on 1 March 2021 and will remain in force for a maximum duration of 18 months. The temporary speed limits are only expected to operate overnight (20:00 – 06:00 hours) for the duration of the works.
