- (a) y bydd darn o gefnffordd yn cael ei adeiladu sy'n cychwyn o bwynt tua 278 o fetrau i'r dwyrain o Gapel Bethel, yng Nghymuned Llanddewi Felffre ac yn ymestyn i gyfeiriad cyffredinol y gorllewin am bellter o tua 4.46 o gilometrau hyd at bwynt ar gefnffordd bresennol yr A40 tua 190 o fetrau i'r gorllewin o'r fynedfa i Penblewin Farm, yng Nghymuned Arberth Wledig, ac y bydd yn dod yn gefnffordd o'r dyddiad pan ddaw'r Gorchymyn i rym;

a:-

- (b) y bydd darn o gefnffordd bresennol yr A40 sy'n cychwyn o bwynt tua 301 o fetrau i'r gorllewin o Gapel Bethel, yng Nghymuned Llanddewi Felffre ac yn ymestyn i gyfeiriad cyffredinol y gorllewin am bellter o tua 1.57 o gilometrau hyd at bwynt ar gefnffordd bresennol yr A40 tua 305 o fetrau i'r dwyrain o'r gyffordd bresennol i Gapel Ffynnon, yng Nghymuned Llanddewi Felffre, ac
- (c) darn o gefnffordd bresennol yr A40 sy'n cychwyn o bwynt tua 138 o fetrau i'r gorllewin o'r eiddo o'r enw Henllan Lodge, yng Nghymuned Llanddewi Felffre ac yn ymestyn i gyfeiriad cyffredinol y gorllewin am bellter o tua 0.75 o gilometrau hyd at bwynt ar gefnffordd bresennol yr A40 yn union i'r dwyrain o ardal orffwyso cefnffordd bresennol yr A40, yng Nghymuned Llanddewi Felffre,

yn peidio â bod yn gefnffyrdd ac yn dod yn ffyrdd dosbarthiadol ar y dyddiad pan fydd Gweinidogion

NOTICE IS HEREBY GIVEN that the Welsh Ministers have made the following Orders—

1. An Order under section 10 and 12 of the Highways Act 1980 providing that:

- (a) a length of trunk road shall be constructed commencing at a point approximately 278 metres east of Bethel Chapel, in the Community of Llanddewi Velfrey and extending in a generally westerly direction for a distance of approximately 4.46 kilometres to a point on the existing A40 trunk road approximately 190 metres west of the entrance to Penblewin Farm, in the Community of Narberth Rural and become a trunk road as from the date when the Order comes into force;

and that:-

- (b) a length of the existing A40 trunk road commencing at a point approximately 301 metres west of Bethel Chapel, in the Community of Llanddewi Velfrey and extending in a generally westerly direction for a distance of approximately 1.57 kilometres to a point on the existing A40 trunk road approximately 305 metres east of the existing junction to Ffynnon Chapel, in the Community of Llanddewi Velfrey, and
- (c) a length of the existing A40 trunk road commencing at a point approximately 138 metres west of the property known as Henllan Lodge, in the Community of Llanddewi Velfrey and extending in a generally westerly direction for a distance of approximately 0.75 kilometres to a point on the existing A40 trunk road immediately east of the existing A40 trunk road rest area, in the Community of Llanddewi Velfrey,

- b. i gau priffyrdd neu rannau o briffyrdd;
- c. i adeiladu priffyrdd newydd;
- d. i gau mynedfeydd preifat i fangreoedd;
- e. i ddarparu mynedfeydd newydd i fangreoedd;
- f. i adeiladu darnau o briffyrdd dros dro; ac
- g. i gau darnau o briffyrdd dros dro,

i gyd ar lwybr y gefnffordd newydd a grybwyllir uchod, neu yn ei gyffiniau; a

yn darparu ar gyfer trosglwyddo pob priffordd newydd i Gyngor Sir Penfro fel yr awdurdod priffyrdd a bennir ar ei chyfer yn y Gorchymyn o'r dyddiad y bydd Gweinidogion Cymru yn hysbysu Cyngor Sir Penfro ei bod wedi ei chwblhau a'i bod ar agor ar gyfer traffig trwodd.

shall cease to be trunk roads and shall become classified roads as from the date on which notice is given by the Welsh Ministers to Pembrokeshire County Council (who will become the highway authority for those lengths).

2. An Order under sections 12, 14, 125 and 268 of the Highways Act 1980 which will authorise the Welsh Ministers:

- a. to carry out the improvement of highways;
- b. to stop up highways or areas of highways;
- c. to construct new highways;
- d. to stop up private means of access to premises;
- e. to provide new means of access to premises;
- f. to construct temporarily lengths of highway, and
- g. to close temporarily lengths of highway.

all on, or in the vicinity of the route of the new trunk road aforesaid; and

provide for the transfer of each new highway to Pembrokeshire County Council as highway authority specified for it in the Order as from the date the Welsh Ministers notify Pembrokeshire County Council that they have been completed and are open for through traffic.

- b. that any requirement of the Act or of regulations made under it has not been complied with,

that person may, within 6 weeks of them becoming operative make an application for the purpose to the High Court.
