Complete and accurate copies of all communications received or issued by Professor Ron Loveland regarding such reports.
- 11. Details of all meetings and visits, UK and overseas, made by Professor Ron Loveland in relation (in whole or in part) to Coal Bed Methane together with (1) copies of all reports prepared following those meetings and visits and (2) copies of all Communications relating to those meetings and visits.

The information you requested is enclosed. Further, in response to question 5 above:

Prof Ron Loveland in his role of the energy adviser to the Welsh Government provides a strategic level oversight of likely future-energy developments at the local, Wales-wide, UK and wider levels but does not advise Ministers or his colleagues on the specific details of any individual commercial-project applications or evaluations
