

**GORCHYMYN CEFNFFYRDD YR A470 A'R  
A489 (CYFFORDD MOAT LANE, CAERSWS,  
POWYS) (TERFYN CYFLYMDER 40 MYA) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 84(1)(a) a (2) a 124(1)(d) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a pharagraff 27 o Atodlen 9 iddi, sy'n dod i rym ar 7 Mehefin 2021.

Effaith y Gorchymyn, sy'n angenreidiol i wella diogelwch ar y ffordd wrth gyffordd Moat Lane, Caersws, Powys, ac yn ei chyffiniau, yw cyflwyno terfyn cyflymder o 40 mya ar:

- i. y darn o gefnffordd yr A470 sy'n ymestyn o bwynt 408 o fetrau i'r de-orllewin o ganolbwyt cyffordd yr A470/A489 Moat Lane, Caersws hyd at bwynt 355 o fetrau i'r gogledd-orllewin o ganolbwyt y gyffordd honno; a
- ii. y darn o gefnffordd yr A489 sy'n ymestyn o ganolbwyt cyffordd yr A470/A489 Moat Lane, Caersws hyd at bwynt 300 metr i'r gogledd-ddwyrain o ganolbwyt y gyffordd honno.

Mae'r Gorchymyn yn dirymu Gorchymyn Cefnffyrd yr A470 a'r A489 (Cyffordd Moat Lane, Caersws, Powys) (Terfyn Cyflymder 50 mya) 2010 (O.S. 2010/2381 (Cy. 2014)).

**THE A470 & A489 TRUNK ROADS (MOAT  
LANE JUNCTION, CAERSWS, POWYS) (40  
MPH SPEED LIMIT) ORDER 2021**

The Welsh Ministers have made an Order in exercise of their powers under sections 84(1)(a) and (2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on 7 June 2021.

The effect of the Order, which is necessary to improve road safety at and in the vicinity of Moat Lane junction, Caersws, Powys, is to introduce a 40 mph speed limit on:

- i. the length of the A470 trunk road that extends from a point 408 metres south-west of the centre-point of the A470/A489 Moat Lane junction, Caersws to a point 355 metres north-west of the centre-point of that junction; and
- ii. the length of the A489 trunk road that extends from the centre-point of the A470/A489 Moat Lane junction, Caersws to a point 300 metres north-east of the centre-point of that junction.

The A470 and A489 Trunk Roads (Moat Lane Junction, Caersws, Powys) (50 mph Speed Limit) Order 2010 (S.I. 2010/2381 (W. 2014)) is revoked by the Order.
