Very happy to set up a slot to discuss the data promise work, I've looped in my colleague Official 6 (REDACTED – SECTION 40) who is leading on this for us.

I've attached an overview presentation which I gave recently which gives a flavour of the different things we're looking at which together look to set the direction for our data policy work this year. We're still awaiting more info on the NHSX Data Strategy and some draft clauses of the UK Government's Health and Care Bill which will give us an idea of the direction being taken in England (as although health and care services are devolved much of the data legislation is not and with so much cross-border data activity it's not as easy as saying 'this is for England only'.

I think key to our success in this is exploiting the non-legislative levers as much as possible whilst planning for medium to longer term legislative changes (either by Welsh Government or UK Government) which may come down the track. We'd like to build on the breakthroughs that COPI Reg 3 (emergency data sharing powers) has given us in improving data sharing in the pandemic, but realising we can't keep extending those powers forever.

If you're able to share some dates for when you'd be available over the next few weeks we'd really welcome getting your views on our overall direction and look at areas we could perhaps work together on.
