ATISN 15227 – Musculoskeletal assessments

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 13 June. You requested information in relation to the Welsh Government's 2017 publication on "Recommended Guidelines: Establishment of a Clinical Musculoskeletal Assessment Treatment Service" ("recommended guidelines") specifically:

- 1. To provide details of the qualifications and level of experience required to be a CMATs lead and provide details of how health boards give assurance to Welsh Government that they are adhering to the recommended guidelines.
- 2. To provide details of the qualifications and level of experience required to be a lead clinician, including standard job description and provide details of how health boards give assurance to Welsh Government that they are adhering to the recommended guidelines.
- 3. To confirm which health boards in Wales are adhering and not adhering to these recommended guidelines, broken down by year since 1 January 2015 to the 13 June 2021.


Our response

Annex A

1. To provide details of the qualifications and level of experience required to be a CMATs lead and provide details of how health boards give assurance to Welsh Government that they are adhering to the recommended guidelines.

The recommended guidelines set out the recommendations for the establishment of a CMAT service. They are not mandatory and serve as guidance/good practice recommendations for health boards to use when setting up their CMAT service. The guidelines clearly state that the CMATS lead needs to be clearly defined and agreed by each health board, and, as a minimum the service should be led by a skilled clinician with postgraduate experience/qualification in the management of MSK conditions as well as leadership skills to head up this service. Ideally a Consultant in Sports and Exercise Medicine would be part of the leadership team.

Whilst we seek assurance from each heath board that they have in place a suitable referral, assessment and treatment service for all soft tissue and joint conditions that are non-inflammatory and do not require emergency treatment, we do not audit health boards against the detail of each guideline.

2. To provide details of the qualifications and level of experience required to be a lead clinician, including standard job description and provide details of how health boards give assurance to Welsh Government that they are adhering to the recommended guidelines.
