Thank you for your request which I received on 16 June 2021. I have set out at Annex 1 the questions you submitted.

Where multiple questions are received and are very broad in their nature they may require a trawl for information across Welsh Government (particularly when a request asks for "any"/ and or "all" information - such as emails or correspondence).

I have established that to provide a response would exceed the appropriate limit established in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004. When calculating whether or not a request exceeds the limit, we are allowed to consider the time it is likely to take to establish if we hold the information, locate the information, retrieve the information and extract it. If these tasks are estimated to take more than 24 hours of working time, the limit will have been exceeded.

With regard to a search using just the term 'Stonewall', this has resulted in the identification of nearly 2000 documents (which could be a combination of word documents, emails etc) - a copy of the search follows. Each document would have to be reviewed to establish if any of the content falls within the scope of the Stonewall part of your question.

If you are able to reframe your questions with a clearer description/focus on the information you are seeking they can be reconsidered - any reformulated questions will be treated as a new request for information.
