ATISN 15256 – COVID-19 in Children

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 21 June 2021. You have requested information regarding Covid-19 in children as follows:

- 1. The number of confirmed Covid-19 cases amongst children in schools.*
- 2. The number of pupils identified as close contact and sent home to self-isolate.*
- 3. Of the pupils sent to self-isolate as a contact of an index case from a school setting, what proportion of those ultimately test positive for SARS-COV-2 within the isolation period?*

Our Response

Welsh Government does not hold this information, however Public Health Wales (PHW) have information in relation to your first point. Should you wish to submit a further Freedom of Information request to PHW, you can do so via the following channel:

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'

- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
