Thank you for your email of 11 July regarding the 'Skills Tracks Matrix.' Responsibility for which, falls within the portfolio of the Minister for Skills and Science, Julie James AM and I have been asked to respond to you on her behalf.

Skills Tracks, known as Employment Routes is the Welsh Government's new approach to mapping skills and employability provision in a way that clearly sets out the support available to individuals. The objective is to enable individuals to easily navigate the full range of support on offer in a user friendly and intuitive way.

As part of our mapping, we have published an overarching provision map. The map details supported European Social Fund (ESF) and core non-ESF skills and employability provision. Available on the Welsh Government's corporate website, the map is scheduled to be updated shortly by a more intuitive and interactive version which will be accessible via the link below


