Thank you for your request which I received on 16th August 2021. You asked for information on:

- 1. The percentage of deaths on Welsh roads where the cause of death was attributed to a vehicle travelling at under 30mph.
- 2. The percentage of deaths on Welsh roads where the cause of death was attributed to a vehicle travelling at over 30 mph.

We do not hold information on the speed at which vehicles were traveling when involved in police recorded road accidents.

We do routinely publish the number of casualties killed, broken down by the speed limit of the road where the police recorded road accident occurred. This information is available on our StatsWales website. The latest data relates to the last quarter of 2020.

As part of the data collection on police recorded road accidents, police officers in attendance of the road accident also record contributory factors which are reason(s) why the accident occurred in the opinion of the attending police officer. One of the possible factors that can be recorded is 'exceeding speed limit'. Should the data published on StatsWales not be sufficient, we may be able to provide data on the number of fatalities where 'exceeding speed limit' was a contributory factor, broken down by the speed limit of the road. However, please note that this will not show the speed at which the vehicle was travelling.

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all



other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
