Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A40, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A40 trunk road, are satisfied that traffic on specified lengths of the trunk road should be restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A40 (Cylchfan Pont Lesneven i Travellers Rest, Caerfyrddin, Sir Gaerfyrddin) (Cyfyngiadau Cyflymder Dros Dro) 2021 a daw'r Gorchymyn hwn i rym ar 1 Medi 2021.

1. The title of this Order is the A40 Trunk Road (Pont Lesneven Roundabout to Travellers Rest, Carmarthen, Carmarthenshire) (Temporary Speed Restrictions) Order 2021 and this Order comes into force on 1 September 2021.

**Interpretation**

2. Yn y Gorchymyn hwn—

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw:

“exempted vehicle” (“*cerbyd esempt*”) means:

  - (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu
  - (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw'r cyfnod sy'n dechrau am 06:00 o'r gloch ar 1 Medi 2021 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A40 Llundain i Abergwaun;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

## Cyfyngiadau

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 30 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 40 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

## Cymhwyso

5.—(1) Nid yw'r cyfyngiadau yn erthyglau 3 a 4 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y mae arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfynau cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

(1) Diwygiwyd adran 87 gan baragraff 55 o Atodlen 1 i Ddeddf Gwasanaethau Tân ac Achub 2004 (p. 21), paragraff 42 o Atodlen 4 i Ddeddf Troseddu Cyfundrefnol Difrifol a'r Heddlu 2005 (p. 15), paragraff 29(2) o Atodlen 8 i Ddeddf Troseddu a'r Llysoedd 2013 (p. 22) ac adran 50(4) a (5) o Ddeddf Dadreoleiddio 2015 (p. 20).

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A40 London to Fishguard trunk road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 06:00 hours on 1 September 2021 and ending when the temporary traffic signs are permanently removed.

## Restrictions

3. No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

4. No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

## Application

5.—(1) The restrictions in articles 3 and 4 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

6. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau modur ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiadau a bennir yn erthyglau 3 a 4 yn gymwys.

## Cyfnod Para'r Gorchymyn hwn

7. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

### Terfyn cyflymder 30 mya neu 40 mya dros dro

Y darn o'r gefnffordd sy'n ymestyn o'i chyffordd ag ochr orllewinol prif gerbyttfordd gylchredol Cylchfan Pont Lesneven hyd at bwynt 1.70 cilometr i'r gorllewin o'r gyffordd honno.

Y darn o ffordd ymuno tua'r dwyrain yr A40 Heol Llansteffan sy'n ymestyn o bwynt 75 o fetrau o'i chyffordd â'r B4312 Heol Llansteffan hyd at ei chyffordd â phrif gerbyttfordd tua'r dwyrain yr A40.

Y darn o ffordd ymuno tua'r gorllewin yr A40 Heol Llansteffan sy'n ymestyn o bwynt 215 o fetrau o'i chyffordd â'r B4312 Heol Llansteffan hyd at ei chyffordd â phrif gerbyttfordd tua'r gorllewin yr A40.

Y darn o ffordd ymadael tua'r gorllewin yr A40 Heol Llansteffan sy'n ymestyn o'i chyffordd â phrif gerbyttfordd tua'r gorllewin yr A40 hyd at bwynt 165 o fetrau o'i chyffordd â'r B4312 Heol Llansteffan.

## SCHEDULE

### Temporary 30 mph or 40 mph speed limit

The length of the trunk road that extends from its junction with the western side of the main circulatory carriageway of Pont Lesneven Roundabout to a point 1.70 kilometres west of that junction.

The length of the A40 Llanstephan Road eastbound entry slip road that extends from a point 75 metres from its junction with the B4312 Llanstephan Road to its junction with the main A40 eastbound carriageway.

The length of the A40 Llanstephan Road westbound entry slip road that extends from a point 215 metres from its junction with the B4312 Llanstephan Road to its junction with the main A40 westbound carriageway.

The length of the A40 Llanstephan Road westbound exit slip road that extends from its junction with the main A40 westbound carriageway to a point 165 metres from its junction with the B4312 Llanstephan Road.
