

**GORCHYMYN CEFNFFORDD YR A48  
(MOUNT PLEASANT, CAS-GWENT, SIR  
FYNWY) (GWAHARDD CERDDWYR DROS  
DRO) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adrann 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A48, neu gerllaw iddi, yng Nghas-gwent, Sir Fynwy.

Effaith y Gorchymyn yw gwahardd dros dro bob cerddwr rhag mynd ar y darn o'r droetffordd sy'n gyfagos i gerbytffordd tua'r dwyrain y gefnffordd ym Mount Pleasant, Cas-gwent, Sir Fynwy sy'n ymestyn o bwynt 65 o fetrau i'r dwyrain o'r gyffordd â Lôn Rhiw Hardwick hyd at y gyffordd â'r B4293.

Y llwybr arall yw mynd ar hyd y droetffordd sy'n gyfagos i gerbytffordd tua'r gorllewin yr A48, ar y tanlwybr i gerddwyr a'r groesfan sydd â signalau dros dro.

Daw'r Gorchymyn i rym ar 31 Awst 2021. Disgwylir y bydd y gwaharddiad dros dro yn weithredol o 20:00 o'r gloch ar 31 Awst 2021 tan 06:00 o'r gloch ar 28 Medi 2021 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnodau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A48 TRUNK ROAD (MOUNT PLEASANT,  
CHEPSTOW, MONMOUTHSHIRE)  
(TEMPORARY PROHIBITION OF  
PEDESTRIANS) ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A48 trunk road at Chepstow, Monmouthshire.

The effect of the Order is to temporarily prohibit all pedestrians from proceeding on the length of the footway adjacent to the eastbound carriageway of the trunk road at Mount Pleasant, Chepstow, Monmouthshire that extends from a point 65 metres east of the junction with Hardwick Hill Lane to the junction with the B4293.

The alternative route is via the footway adjacent to the A48 westbound carriageway, the pedestrian subway and the temporary signalled crossing.

The Order comes into force on 31 August 2021. The temporary prohibition is expected to operate from 20:00 hours on 31 August 2021 until 06:00 hours on 28 September 2021 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the periods specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
