## **Request for Information – ATISN 15458**

Thank you for your request for information dated 24 August.

### **Information requested**

An up to date list of suppliers, subcontractors and consultants that have or will be involved with the development of the A465 Hirwaun to Dowlais Top Sections 5 & 6.

### **Our Response**

I confirm the Welsh Government holds the information caught by your request.

The Welsh Government's principal suppliers were Jacobs (Technical), PwC (Financial) and DLA Piper (Legal) in the scheme's development (up to the award of contract to design, build, finance and operate the A465 Dowlais to Hirwaun in October 2020).

The Welsh Government also received consultancy support from Local Partnerships LLP (a joint HM Treasury/Welsh Government limited liability partnership) and Hays Specialist Recruitment Ltd in respect of interim staff.

It is now in detailed design and construction by Future Valleys Project Co Ltd (this information is in the public domain by way of an OJEU contract award notice - [https://www.sell2wales.gov.wales/search/show/search\\_view.aspx?ID=NOV353061](https://www.sell2wales.gov.wales/search/show/search_view.aspx?ID=NOV353061)) who will also be responsible for the operation and maintenance of the road for 30 years post-construction.
