Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A470, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi, a'r tebygolrwydd o berygl i'r cyhoedd os bydd llifogydd.

The Welsh Ministers, as traffic authority for the relevant length of the A470 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road and likelihood of danger to the public during potential flooding incidents.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Llanrwst, Conwy) (Gwahardd Cerbydau, Beicwyr a Cherddwyr Dros Dro) 2021 a daw'r Gorchymyn hwn i rym ar 1 Hydref 2021.

Title and commencement

1. The title of this Order is the A470 Trunk Road (Llanrwst, Conwy) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2021 and this Order comes into force on 1 October 2021.

Dehongli

2. Yn y Gorchymyn hwn—

ystyr “cyfnod y gwaith” (“*works period*”) yw'r cyfnod sy'n dechrau am 00:01 o'r gloch ar 1 Hydref 2021 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

Interpretation

2. In this Order—

“the trunk road” (“*y gefnffordd*”) means the length of the A470 Maentwrog to East of Conwy trunk road that extends in a south-easterly direction from the south-eastern parapet of Pont Fawr at its junction with the B5106, for a distance of 20 metres;

ystyr “y gefnffordd” (“*the trunk road*”) yw’r darn o gefnffordd yr A470 Maentwrog i Fan i’r Dwyrain o Gonwy sy’n ymestyn i gyfeiriad y de-ddwyrain o barapet de-ddwyreiniol y Bont Fawr wrth ei chyffordd â’r B5106, am bellter o 20 metr.

Gwaharddiadau

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o’r gefnffordd.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, reidio unrhyw feic pedal ar y darn o’r gefnffordd.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, gerdded ar y darn o’r gefnffordd.

Cymhwyso

6. Ni fydd y gwaharddiadau yn erthyglau 3, 4 a 5 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

Cyfnod Para’r Gorchymyn hwn

7. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“works period” (“*cyfnod y gwaith*”) means the period commencing at 00:01 hours on 1 October 2021 and ending when the temporary traffic signs are permanently removed.

Prohibitions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road.

5. No pedestrian may, during the works period, proceed on the length of the trunk road.

Application

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order is 18 months.
