

**GORCHYMYN CEFNFFORDD YR A479 (PARC
GLAN-WYSG I DRETŴR, POWYS) (TERFYN
CYFLYMDER 50 MYA DROS DRO) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn oherwydd y tebygolrwydd o berygl i'r cyhoedd ar gefnffordd yr A479, neu gerllaw iddi, rhwng Parc Glan-wysg a Thretŵr, Powys.

Effaith y Gorchymyn yw gosod terfyn cyflymder 50 mya dros dro ar y darn o gefnffordd yr A479 sy'n ymestyn o ganolbwynt ei chyffordd â'r A40 ym Mharc Glan-wysg hyd at bwynt 75 o fetrau i'r de-ddwyrain o'i chyffordd â Heol Saeson (ffordd sirol yr U495) yn Nhretŵr.

Daw'r Gorchymyn i rym ar 21 Medi 2021. Disgwylir y bydd y cyfyngiad dros dro yn weithredol o 00:01 o'r gloch ar y dyddiad hwnnw am gyfnod o 18 mis ar y mwyaf.

**THE A479 TRUNK ROAD (GLANUSK PARK
TO TRETOWER, POWYS) (TEMPORARY 50
MPH SPEED LIMIT) ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary because of the likelihood of danger to the public on or near the A479 trunk road between Glanusk Park and Tretower, Powys.

The effect of the Order is to temporarily impose a 50 mph speed limit on the length of the A479 trunk road that extends from the centre-point of its junction with the A40 at Glanusk Park to a point 75 metres south-east of its junction with Heol Saeson Lane (county road U495) at Tretower.

The Order comes into force on 21 September 2021. The temporary restriction is expected to operate from 00:01 hours on that date for a maximum duration of 18 months.
