Request for information - Clean Air Survey

We wrote to you on 15 September regarding your request for information.

Information requested

You asked for the following specific information in relation to the recent Clean Air Zone travel behaviour survey:

- 1. The businesses that were surveyed
- 2. The format in which the survey was circulated
- 3. The number of consultants employed
- 4. Consultancy costs

Our response

The information you requested is enclosed. By way of providing some context to the survey, I should draw your attention to the following advice which was shared with survey recipients.

'Areas of poor air quality have previously been identified on the M4 between Junction 25, Caerleon Road and Junction 26, Malpas Road in Newport and the A470 between Pontypridd and Upper Boat/Treforest where levels of pollution (principally nitrogen dioxide) are above legal limits. In recognition of this problem, the Welsh Government has been assessing potential solutions and packages of measures to improve air quality and protect the health of people.

We welcome receiving correspondence in Welsh. Any correspondence received in Welsh will be answered in Welsh and corresponding in Welsh will not lead to a delay in responding.



In 2018 and 2019, measures to improve air quality including 50mph speed limits and Average Speed Cameras were installed at both locations. Whilst to date, the measures have helped improved air quality, the Welsh Government are currently developing further solutions including the introduction of a Clean Air Zone, which may entail charging certain types of vehicles (with high emissions) that travel along the above sections of M4 and A470. If such a charge was to be implemented, it would be a single charge applied on a daily basis irrespective of the number of trips made throughout the day on either M4 or A470 or both.

This work is necessary as the Welsh Government are legally required to improve air quality and reduce harmful levels of nitrogen dioxide in the shortest possible time and whilst at this stage a Clean Air Zone is not proposed at these locations, all potential options must be developed should they be required in the future.

This survey is seeking to obtain information that will assist in identifying what these potential solutions or interventions might be and the consequent possible impacts on local people and businesses in the district.'

Next steps

Survey format

The survey was undertaken in two waves; firstly for drivers of private cars and light goods vehicles used for private purposes, and secondly for commercial enterprises that operate vehicles as part of their business.

For the private survey, postcards were delivered to a random sample of addresses in the vicinity of the M4 Newport J25-J26 and A470 Upper Boat to Pontypridd. The postcards invited recipients to undertake the survey online. Paper copies of the survey were also made available should recipients be unable to access the survey online. In addition, drivers were also approached at motorway and A-road service areas and petrol stations in the region, and invited to participate.

Surveys of commercial vehicle drivers or decision makers were undertaken using a Computer Aided Telephone Interviewing (CATI) approach. Businesses that operate in the CF and NP postcode areas of South Wales were randomly selected from the Wales Business Register.

Number of consultants employed

One consultant has been appointed to assess the potential of Clean Air Zones to contribute to the achievement of compliance with legal limits for nitrogen dioxide in ambient air at two locations:-

- 1. A470, between Upper Boat to Pontypridd
- 2. M4 Newport, between J25 to J26

Consultancy costs

The consultancy contract extends to the development several measures for their potential to support the delivery of legal compliance with nitrogen dioxide limits at five exceeding locations on the strategic road network.

The costs incurred for the development work this year to date, including, but not limited to, the design and undertaking of the Clean Air Zone stated preference survey, updating the strategic traffic model, and provision of professional advice, amounts to £315,550.

Please note that these costs also include development work on other potential measures for exceeding locations elsewhere on the strategic road network, which forms part of the same contract.
