ATISN 15604 – Exercise Alice

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 18 October. You requested the following -

- 1. Please state (yes or no) whether the Welsh government sent any communications regarding Exercise Alice between 1 February 2016 and 30 April 2016.*
- 2. Please state (yes or no) whether the Welsh government received any communications regarding Exercise Alice between 1 February 2016 and 30 April 2016.*
- 3. Please share copies of any stored records of communications sent or received by the Welsh government between 1 February 2016 and 30 April 2016 (emails, memoranda, faxes, text messages, online messages, phone calls, letters, or any other relevant form of communications)*

Response

For points 1 and 2 we can confirm that no communications was sent or received by the Welsh Government regarding Exercise Alice between 1 February 2016 and 30 April 2016. For point 3 we can confirm that we do not hold the information you have requested.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
