ATISN 15619 – Integrated Autism Service (ISA)

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 22 October regarding the Integrated Autism Service. You requested the following information:

- What person(s) first suggested the formation of the Integrated Autism Service (IAS) in Wales?
- For each year and each county, please provide information regarding the total expenditure of the Integrated Autism Service, including a break-down on what this was spent on.

Our response

- Welsh Government are unable to establish the 'first person' who suggested the formation of the Integrated Autism Service, however in March 2016, as part of the refreshed Autistic Spectrum Disorder Strategic Action Plan (ASD SAP), the Welsh Government announced that it would be funding a new national Integrated Autism Service (IAS). The Minister for Health and Social Care at this time was Mark Drakeford AM.
- Welsh Government does not hold the information relating to the break-down on where funding was spent as allocation of funds has been through the Integrated Care Fund. However, we are able to provide the allocations per financial year for each of the 7 regions and is shown in £m see attached.

Next Steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response.
