

**GORCHYMYN CEFNFFORDD YR A40
(FFORDD OSGOI ABERHONDDU, POWYS)
(GWAHARDD CERBYDAU, BEICWYR A
CHERDDWYR DROS DRO) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn arfaethedig er mwyn gwneud gwaith ar Ffordd Osgoi Aberhonddu cefnffordd yr A40, neu gerllaw iddi, yn Sir Powys.

Effaith y Gorchymyn fydd gwahardd dros dro bob cerbyd, beiciwr a cherddwr rhag mynd ar y darn o gefnffordd yr A40 rhwng Cylchfan Brynich a Chylchfan Tarell yn Aberhonddu, Powys.

Y llwybr arall ar gyfer traffig sy'n teithio tua'r gorllewin o ben dwyreiniol y darn o'r ffordd sydd ar gau fydd mynd ar yr A470 tua'r gogledd i Lanfair-ym-Muallt, ar yr A483 tua'r de-orllewin i Lanymddyfri i ailymuno â'r A40. I'r gwrthwyneb ar gyfer traffig sy'n teithio tua'r dwyrain o ben gorllewinol y darn o'r ffordd sydd ar gau.

Disgwylir i'r gwaharddiadau dros dro, y codir arwyddion priodol yn eu cylch, ddod i rym am 00:00 o'r gloch ar 6 Rhagfyr 2021, a byddant mewn grym am gyfnod o 18 mis ar y mwyaf. Disgwylir i'r ffordd gau yn ysbeidiol dros nos naill ai ar y gerbyttffordd tua'r gorllewin neu'r gerbyttffordd tua'r dwyrain rhwng 20:00 o'r gloch a 06:00 o'r gloch neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A40 TRUNK ROAD (BRECON BYPASS,
POWYS) (TEMPORARY PROHIBITION OF
VEHICLES, CYCLISTS AND PEDESTRIANS)
ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to undertake works on or near the A40 trunk road Brecon Bypass in the County of Powys.

The effect of the Order will be to temporarily prohibit all vehicles, cyclists and pedestrians from proceeding on the length of the A40 trunk road between Brynich Roundabout and Tarell Roundabout at Brecon, Powys.

The alternative route for westbound traffic from the eastern extent of the closure will be via the A470 northbound to Builth Wells, A483 south-westbound to Llandovery to re-join the A40. Vice versa for eastbound traffic from the western extent of the closure.

The temporary prohibitions, which will be signed accordingly, are expected to come into force at 00:00 hours on 6 December 2021 and will be in force for a maximum period of 18 months. The road closure is expected to operate intermittently overnight on either the westbound carriageway or the eastbound carriageway between 20:00 hours and 06:00 hours or until the temporary traffic signs are permanently removed. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
