

**GORCHYMYN CEFNFFORDD YR A470  
(TALERDDIG, POWYS) (GWAHARDD  
CERBYDAU DROS DRO) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, wrth bont reilffordd Pont Bell, Talerddig, Powys.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys, ar gyfer y gwaith neu cerbydau gwasanaeth cynnal a chadw'r gaeaf, rhag mynd ar y darn o gefnffordd yr A470 sy'n ymestyn am bellter o 20 metr y naill ochr a'r llall i bont reilffordd Pont Bell.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r gogledd fydd mynd ar yr A470 tua'r de i Gaersŵs, yr A489 tua'r dwyrain i'r Drenedydd, yr A483 tua'r gogledd-ddwyrain i'r Trallwng a'r A458 tua'r gorllewin i Fallwyd i ailymuno â'r A470 tua'r de/gogledd yng Nglantwymyn: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r de.

Daw'r Gorchymyn i rym ar 2 Rhagfyr 2021. Disgwylir y bydd y gwaharddiad dros dro yn weithredol o 23:00 o'r gloch ar 2 Rhagfyr 2021 hyd 06:00 o'r gloch ar 3 Rhagfyr 2021 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A470 TRUNK ROAD (TALERDDIG,  
POWYS) (TEMPORARY PROHIBITION OF  
VEHICLES) ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A470 trunk road at Pont Bell railway bridge, Talerddig, Powys.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services, for the works or winter maintenance service vehicles, from proceeding on the length of the A470 trunk road that extends for a distance of 20 metres either side of Pont Bell railway bridge.

The alternative route for northbound vehicles will be via the southbound A470 to Caersŵs, eastbound A489 to Newtown, north-eastbound A483 to Welshpool and westbound A458 to Mallwyd to rejoin the south/northbound A470 at Cemmaes Road: vice versa for southbound vehicles.

The Order comes into force on 2 December 2021. The temporary prohibition is expected to operate from 23:00 hours on 2 December 2021 until 06:00 hours on 3 December 2021 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the period specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
