

**GORCHYMYN CEFNFFORDD YR A494
(STRYD FAWR, Y BALA, GWYNEDD)
(GWAHARDD CERBYDAU DROS DRO) 2021**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 16A o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn hwyluso cynnal y Gwasanaeth Coffa ar Sul y Cofio ar gefnffordd yr A494 yn y Bala yn Sir Gwynedd.

Effaith y Gorchymyn fydd gwahardd dros dro bob cerbyd (ac eithrio'r rhai a ddefnyddir gan drefnwyr y Gwasanaeth Coffa ar Sul y Cofio, cerbydau gwasanaeth cyhoeddus a cherbydau'r gwasanaethau brys) rhag mynd ar y darn o'r gefnffordd o'r enw Stryd Fawr sy'n ymestyn o ganolbwynt ei chyffordd â Heol Aran hyd at ganolbwynt ei chyffordd â Heol y Domen.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de y bydd cau'r gefnffordd yn effeithio arnynt fydd mynd tua'r gorllewin ar yr A4212 o'r Bala i Drawsfynydd a thua'r de ar yr A470 i Ddolgellau i ailymuno â'r A494. I'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd.

Disgwylir y bydd y gwaharddiad, y codir arwyddion priodol yn ei gylch, yn weithredol o 10:40 o'r gloch hyd 11:20 o'r gloch ar 14 Tachwedd 2021 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

**THE A494 TRUNK ROAD (HIGH STREET,
BALA, GWYNEDD) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2021**

The Welsh Ministers have made an Order under section 16A of the Road Traffic Regulation Act 1984 which is necessary to facilitate the holding of the Remembrance Sunday Memorial Service on the A494 trunk road at Bala in the County of Gwynedd.

The effect of the Order will be to temporarily prohibit all vehicles (other than those being used by organizers of the Remembrance Sunday Memorial Service, public service and emergency service vehicles) from proceeding on the length of the trunk road known as High Street that extends from the centre point of its junction with Aran Street to the centre point of its junction with Mount Street.

The alternative route for southbound vehicles affected by the closure will be via the A4212 westbound from Bala to Drawsfynydd and the A470 southbound to Dolgellau to re-join the A494. Vice versa for northbound vehicles.

It is expected that the prohibition, which will be signed accordingly, will operate from 10:40 hours until 11:20 hours on 14 November 2021 or until the temporary traffic signs are permanently removed.
