Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 20 December 2021 relating to the performance of the Swansea Bay University Health Board. You requested the following:

- 1. Minimum, Maximum and average times it took Swansea Bay Health Board to respond to formal complaints from initial receipt of the complaint to the first response to the complainant, during Jan through to Dec 2021.
- 2. Any documentation, flowcharts, policies etc that Medics/pharmacists follow to decide the risk benefit analysis for blood thinners when there is a known patient haemorrhaging risk.
- 3. Please also include any documentation/policies/flowcharts etc for the process that should be followed should a patient start haemorrhaging on a new blood thinner prescribed by a medic at hospital. This is for both inpatients and those patients who are day cases and discharged home? For 2020 and 2021
- 4. Please provide the policy, protocol, flowchart etc for patients with suspected memory impairment (waiting for assessment or families raise concerns) vs obtaining consent for procedures and Do Not Resuscitate. For 2020 and 2021.
- 5. During Dec 2020, please confirm if all patients admitted to HDU at Singleton hospital received a Covid test at admission (the same day) or if their Covid status was already known at admission. If not, how many patients were transferred to other hospitals without a known Covid status?
