ATISN 15717 – Seren programme funding and outcomes

Information requested

Thank you for your request which I received on 26 November 2021. You asked for four pieces of information related to the Seren Programme:

- 1. Total Welsh Government expenditure on the Seren programme since the start of the programme in 2015 (with a yearly breakdown),
- 2. How many students on the programme have gone to a) Oxford University b) Cambridge University c) International (non-UK) Universities since the start of the programme in 2015,
- 3. A yearly breakdown for each of the 'regional hubs' on how many pupils from each hub has gone to a) Oxford and b) Cambridge Universities since Seren started in 2015 and
- 4. A yearly breakdown on how much money Welsh Government has allocated to each of the 'regional hubs' since Seren started in 2015.

Our response

A copy of the information we hold is enclosed.

Following a search of our paper and electronic records, I have established that not all of the information you require is held by the Welsh Government.

1. Total Welsh Government expenditure on the Seren programme since the start of the programme in 2015 (with a yearly breakdown) - is detailed below in Table 1.

A detailed breakdown of the annual funding per hub is show in Table 2 below. It should be noted that financial year 2018/19 saw the first full year of delivery across Wales where each hub received a funding allocation. Prior to this, the policy was under development. Powys, Bridgend and Neath Port Talbot originally piloted Seren as a consortium then separated in 2018-19 as seen in table 2.
