Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 13 December 2021 relating to the Track and Trace programme. You requested the following:

 Who is actually processing the data being harvested via the Track, Trace & Protect programme please? I require the name of the statutory bodies, private companies & any other organisation involved in any part of the process.

### **Our Response**

To deliver the Test, Trace and Protect strategy personal data is collected and processed for a variety of reasons. NHS Wales provides information about the personal data that is being collected, by whom, how it is being used on its website:

Health in Wales | Test, Trace and Protect - Privacy & Data Protection Information

Particularly in relation to Covid-19 testing, the Welsh Government has worked collaboratively with the UK Government's Department for Health and Social Care (DHSC) and the other Devolved Governments to deliver testing across the United Kingdom through a National Testing Programme (NTP).

Through the NTP, the Welsh Government has made arrangements for DHSC to enter into contracts to secure the provision of Covid-19 testing in Wales. In processing personal data for the purposes of providing testing services, DHSC will comply, and ensure that all suppliers comply, with all relevant data protection law. Welsh Government does not hold the details of individual companies that are employed by DHSC and advise you to contact DHSC directly.
