Request for Information – ATISN 15871

Thank you for your request for information regarding the 50mph speed limits on the A483 Wrexham and A494/A550 Ewloe to Deeside Park Interchange

Information requested

You have asked the following:

- 1. The full cost of implementing these restrictions on both roads.
- 2. The recorded nitrous oxide emission levels before and after the restrictions were introduced.
- 3. The recorded injury statistics(year by year) before and after restrictions.
- 4. The recorded mean speeds before and after the speed limit introduction.
- 5. How many motorists have been recorded exceeding the average speed limit and how many have been subject to enforcement/prosecution.
- 6. Has enforcement been reliant solely on the average speed equipment or have police also been also been undertaking enforcement action how many offences have been recorded by each system.

- 5. Since October 2021, 17405 advice letters have been issued. Since the commencement of enforcement in November 2021, 1096 motorists have been sent Notices of Intended Prosecution.
- 6. Enforcement is by the Average Speed Cameras only.
