## **ATISN 15905**

Thank you for your request which I received on 29 December 2021. You asked for the following information:

- 1. Please list the identified benefits of Brexit that was enacted by H.M.'s Government & advanced by the Commons after the majority leave vote at referendum in 2016;
- 2. Of the identified benefits in part '1)', specific benefits to Wales?
- 3. Of the identified benefits in part '1)', specific benefits in terms of the legal system and budgets? and
- 4. What progress has been made in initiating & facilitating Brexit in Wales?

I wrote to you on 6 January 2022 to seek clarification of parts 1-3 of your request. I asked if you could confirm whether you are seeking information held by the Welsh Government listing identified benefits of the UK's exit from the EU. I have not received any response, so I am interpreting your request on this basis.

I attach two specific documents which are relevant to the scope of your request, which are:

- A 'Discussion paper on the Brexit Premium' prepared by the Public Policy Institute for Wales in November 2016 for a meeting of the European Advisory Group; and
- The minutes of that meeting of the European Advisory Group.

More broadly, since the UK voted to leave the European Union in June 2016, the Welsh Government has issued a number of publications setting out its views on the potential impacts and implications for Wales of the UK's departure from the EU, its position on what future relationship with the EU would best serve the interests of the people of Wales, and how replacements for EU policies and programmes should be designed, beginning with 'Securing Wales Future'. These publications will include any potential opportunities which were identified, depending on the nature of the UK's future relationship with the EU. In relation to the implementation of EU exit, the Welsh Government published in November 2021 its End of Transition Action Plan. The plan set out the actions the Welsh Government took to ensure that businesses and citizens in Wales were prepared for any outcome of what at the time were still ongoing negotiations between the UK and the EU.
