

**GORCHYMYN CEFNFFORDD YR A470
(LLANRWST, BWRDEISTREF SIROL CONWY)
(GWAHARDD CERBYDAU A BEICWYR DROS
DRO) 2022**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, yn Llanrwst, Conwy.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd a beiciwr rhag mynd ar:

- i. y darn o gefnffordd yr A470 sy'n ymestyn o'i chyffordd â Ffordd Pari hyd at ei chyffordd â'r A548 Heol Dinbych; a
- ii. y darn o gefnffordd yr A470 sy'n ymestyn o'i chyffordd â'r A548 Heol Dinbych hyd at ei chyffordd â'r B5106 y Bont Fawr.

Bydd y gwaith yn cael ei wneud mewn 2 gam. Y llwybr arall ar gyfer traffig sy'n teithio tua'r gogledd pan fydd y darn o'r gefnffordd a nodir yn i. uchod ar gau yw mynd tua'r gogledd ar Ffordd Tanyrysgol a Ffordd Talybont a thua'r gorllewin ar Ffordd Pari. Dylai cerbydau sy'n teithio tua'r de ddilyn Ffordd Pari tua'r dwyrain, Ffordd Talybont tua'r de, Heol Dinbych tua'r gorllewin a Heol Watling tua'r de.

Y llwybr arall ar gyfer traffig sy'n teithio tua'r gogledd pan fydd y darn o'r gefnffordd a nodir yn ii. uchod ar gau yw mynd ar y ffordd arall a ddisgrifir uchod. Dylai cerbydau sy'n teithio tua'r de ddilyn yr A458 tua'r dwyrain a Heol Watling tua'r de.

Ni fydd modd i gerbydau dros 3 metr o led ac sy'n pwyso mwy na 7.5 tonnell (ac eithrio'r rheini sy'n cael eu defnyddio gan y gwasanaethau brys ac ar gyfer trafndiaeth gyhoeddus leol) ddefnyddio'r llwybrau dargyfeirio a ddisgrifir uchod. Dylai cerbydau o'r fath sy'n teithio tua'r gogledd ddilyn yr A470 tua'r de i Fetws-y-coed, yr A5 tua'r gogledd-orllewin i Gyffordd 11 yr A55 (Cyfnewidfa Llys y Gwynt), yr A55 tua'r dwyrain i Gyffordd 19 (Glan Conwy) a'r A470 tua'r de: i'r gwrthwyneb ar gyfer cerbydau nwyddau trwm sy'n teithio tua'r de.

Daw'r Gorchymyn i rym ar 28 Chwefror 2022. Disgwylir y bydd y gwaharddiadau dros dro yn weithredol o 00:01 o'r gloch ar 28 Chwefror 2022 hyd 23:59 o'r gloch ar 31 Mawrth 2022 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

**THE A470 TRUNK ROAD (LLANRWST,
CONWY COUNTY BOROUGH) (TEMPORARY
PROHIBITION OF VEHICLES & CYCLISTS)
ORDER 2022**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to undertake works on or near the A470 trunk road at Llanrwst, Conwy.

The effect of the Order is to temporarily prohibit all vehicles and cyclists from proceeding on:

- i. the length of the A470 trunk road that extends from its junction with Parry Road to its junction with the A548 Denbigh Street; and
- ii. the length of the A470 trunk road that extends from its junction with the A548 Denbigh Street to its junction with the B5106 Pont Fawr.

The works will be undertaken in 2 phases. The alternative route for northbound traffic during the closure at i. above is via the northbound School Bank Road and Talybont Road and westbound Parry Road. Southbound traffic should follow the eastbound Parry Road, southbound Talybont Road, westbound Denbigh Street and southbound Watling Street.

The alternative route for northbound traffic during the closure at ii. above is via the alternative route described above. Southbound vehicles should follow the eastbound A458 and southbound Watling Street.

Vehicles over 3 metres wide and weighing in excess of 7.5 tonnes (other than those being used by the emergency services and for local public transport) will be unable to use the diversion routes described above. Such northbound vehicles should follow the southbound A470 to Betws-y-Coed, north-westbound A5 to the A55 Junction 11 (Llys y Gwynt Interchange), eastbound A55 to Junction 19 (Glan Conwy) and southbound A470: vice versa for southbound HGVs.

The Order comes into force on 28 February 2022. The temporary prohibitions are expected to operate from 00:01 hours on 28 February 2022 until 23:59 hours on 31 March 2022 or until the temporary traffic signs are permanently removed.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf, rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.
