**NOTICE IS HEREBY GIVEN** that the Public Local Inquiry into the above named draft Orders for the A55 Junctions 14-16A improvement scheme (the "Scheme") is formally **cancelled with immediate effect**.

This is as a consequence of the Ministerial announcement on 10 February 2022 in respect of his decision that the Scheme should not proceed in its current form.

A decision has been made to withdraw the above draft Orders. The application for the Certificate under Section 19 of the Land Acquisition Act 1981 has also been withdrawn.
